01. CALL TO ORDER:

Chairman Tex G. Hall called the meeting to order at 12:14 p.m. with an opening prayer by Gertrude Sillitti.

Treasurer Wells informed the Business Council that Directors of the Programs were asked to submit their budgets for fiscal year 2000 but he has not received all of them so he could not present the Council with a draft today. The change from fiscal years 1999 is he was going to include the personnel from the indirect cost budget because when Personnel decisions are made, we say indirect but nothing has been on paper. Chairman Hall asked for an update on the IIM and small loans account. The Radio Communications wants to be audited.

Councilman Tom Bird Bear made an announcement that he was planning on having a community meeting for North Segment on the 28th or 29th regarding FSA class action.

Councilman Daylon Spotted Bear said he only had two items and one is already on the agenda. The other item was the general manager of the Casino. There were eleven applicants and only two met the minimum qualifications who were Spencer Wilkinson, Jr., and Bernie Fox.

Councilman Mark Fox informed the Committee he attended a joint meeting with the Bureau of Indian Affairs, ITMA and other tribal organizations. The intent of the meeting was to devise methods and means of estimating what the Tribe's losses were. He presented a folder to the Chairman with the information gone over at the meeting along with their agenda. He presented dates on other upcoming meetings.

Councilman Marcus Wells, Jr. stated on the COPS FAST grant application the Tribe has less than fifteen days to get their request in. He sent a memorandum to Jeannette Coffey and she said she never received the application. This is an application for equipment and cars. Brent LaRocque stated he gave the application to Bonnie Pedro.

Councilman Pete Hale said he has a resolution to present on behalf of Jody Hale Brieck. The Tribal Business Council had approved her for a loan of \$3,000 and a grant of \$3,000

but they could not use the land collateral so Ed Hale's wage deductions were added instead. He said he also got two proposals from Capitol Credit on refinancing the Casino and one to refinance the Casino and the buffalo project.

Councilman Pete Hale motioned to approve the amendment of Jody Hale-Brieck's resolution as follows: BE IT FINALLY RESOLVED, The Tribal Business Council hereby authorizes the release of Tribal funds in the amount of \$3,000.00 in the form of a grant and \$3,000.00 in the form of a loan with a 8.25% APR, \$50.00 bi-weekly wage deduction, to be put into effect by Ed Hale, and beginning September 23, 1999, until paid in full for the loan as collateral. Seconded by Councilman Tom Bird Bear.

Discussion: Councilman Fox asked if this was for a business off the Reservation in which Councilman Hale replied it was. Discussion followed on the loan and the previous resolution itself and why the land was not held as collateral.

Councilman Daylon Spotted Bear informed the Committee the minutes of June 23, 1999, July 15 & 16, 1999 and August 12, 1999 would have to be deferred as Marlien Mossett has the minutes in the packets and she is not here.

06. BNC BANK - BRAD SCOTT:

Chairman Hall said Community 1st done a presentation on the JTAC monies and Brad Scott of BNC Bank will do the same. Mr. Scott said they are the seventh largest bank in the State of North Dakota and he and other staff of the BNC Bank went into detail on how they could best serve the Three Affiliated Tribes.

07. CENEX PIPELINE PROPOSAL:

Chairman Hall asked El Marie Conklin to be present at this meeting along with the Legal Department. Mr. Danny Foss said Mr. Daniel Knepper was advised he did not have to be present at this meeting by Tom Disselhorst. Chairman Hall summarized the proposal for the Council members which was presented by Cenex Pipeline. It is a renewal of the contract, they would like to renew it for another twenty years. It comes across underneath the Bridge and through the parking lot west about five miles. Ms. El Marie Conklin explained her memorandum to the Tribal Business Council that was dated August 17, 1998 on this agreement. Discussion followed on this topic. Mr. Foss said they paid \$65.00 per rod for a permanent right of way on this and the State of North Dakota allows it for ninety-nine years. On fee land they pay \$15.00 per rod. Mr. Tom Disselhorst summarized the memorandum he had wrote on this issue. The Councilmen expressed their opinions on the offer Cenex Pipeline offered. Chairman Hall stated he would like to negotiate a higher price, that the BIA hold a meeting with the allottees, and have another meeting with Cenex. Councilman Austin Gillette said he felt this was a fair offer. It was decided to conduct a public meeting with El Marie Conklin present to discuss this issue. Ms. Conklin informed the Tribal Business Council that she received a request from the Colorado University Law Clinic to have the Tribe join in on the Amius Brief that is going to be filed with Big Horn Electric versus Dennis Adams. This case is going to the ninth circuit. The issue with Big Horn Electric is the same as in RTC.

Councilman Tom Bird Bear motioned to support the Crow Tribe in their taxation dispute as an amicus party to the lawsuit the Tax Director has recommended subject to the concurrence between the Tribal Tax Department and Tribal Legal Department. Seconded by Councilman Pete Hale.

Discussion: Councilman Mark Fox felt a legal review should be completed prior to moving forward with this.

17. PATTI FREDEICKS - MILLER & SCHROEDER:

Ms. Patti Fredericks, First Vice President of the Miller & Shcroeder Investments Corporation presented a loan proposal on a taxable loan and a tax exempt loan to the Three Affiliated Tribes to refinance the outstanding principal balance of the existing loan for the Four Bears Casino & Lodge in the amount of approximately \$4,200,000 and fund the expansion of the casino, legal counsel fees and Miller & Schroeders' placement fees. The tax exempt loan will be to provide funds to the Tribal government and help with the construction of the convention/events center along with fees and expenses.

18. MARILYN YELLOW BIRD - COMMUNITY HEALTH PROGRAM

Ms. Yellow Bird explained her emergency medical services to the Tribal Business Council. Her proposal was to assist with the local shortage of manpower on the New Town Ambulance service. She said their biggest issue was they never received payment from the Tribe for this year and the second concern was lack of manpower. In turn the New Town

Mr. Ambrose Phelan addressed the Tribal Business Council in which he stated that at the time he wrote the resolution he was asking for a loan or a grant but realizes the financial status of the Tribe. Now he is asking if the Tribe would secure a loan for him from BNC. He spoke with BNC and they said if the Tribe secured a loan, he would have no problem in obtaining it. He is asking for \$20,000.00. \$14,000 would go to pay for the installation of an electric line from McKenzie Electric, \$2,500.00 to pay for a water well and pump, \$1,5000.00 for skirting materials and \$2,000.00 for miscellaneous expenses. He is willing to have his land as collateral for this loan in which he has 36 acres of top soil and 80 acres of mineral rights. He has been working with Kip Quale on this. Mr. Phelan further explained how he is required to pay \$14,000.00 for a line that is less than one mile and others who had a longer distance paid pay less money. Discussion followed on this topic and possible solutions to it.

Councilman Mark Fox motioned to direct the legal department to assist Ambrose Phelan in this issue and to be an advocate and to help process an application for services with the electric cooperative so they can obtain electricity. The Legal Three Affiliated Tribes
