



**RESOLUTION OF THE GOVERNING BODY OF THE  
THREE AFFILIATED TRIBES OF THE  
FORT BERTHOLD INDIAN RESERVATION**

*A Resolution entitled, "Consent to Certain Rights of Way across Tribal land for the  
McKenzie Electric Cooperative – South Segment Motel Project"*

**WHEREAS,** This Nation having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws under said Act, and

**WHEREAS,** Pursuant to Article III, Section 1 of the Constitution and By-Laws of the Three Affiliated Tribes, also known as the Mandan, Hidatsa, and Arikara Nation ("Tribes" or "MHA Nation"), the Tribal Business Council is the governing body of the Tribes; and

**WHEREAS,** Pursuant to Article VI, Section 5(1) of said Constitution, the Tribal Business Council has the power to adopt resolutions regulating the procedures of the Tribal Council, its Agencies and Officials; and

**WHEREAS,** Article IX, Sections 1 and 3 of the Constitution provide that the Tribal Business Council has the authority to manage and lease or otherwise deal with Tribal lands and resources; and

**WHEREAS,** The applications for Rights of Way (ROWs) described herein have been reviewed and recommended for approval in accordance with the MHA Nation's approved procedure for authorizing ROWs on Tribal land; and

**WHEREAS,** The Tribal Business Council finds it appropriate to authorize the ROWs described herein in consideration of the public benefit the granting of the ROWs provides.

**NOW THEREFORE BE IT RESOLVED,** that the Tribal Business Council of the Three Affiliated Tribes hereby accepts payment and consents to the following ROW(s):

1. McKenzie Electric Cooperative will be constructing an Electrical Service Line in South Segment. The easement will run a variable width for Three Phase Power lines, for the South Segment Motel Project across certain Tribal lands in:
  - a. Allotment T704A-D, Section 28, T. 147 N., R. 91 W., Dunn County, 5<sup>th</sup> Principal Meridian of North Dakota, with a 100% Tribal interest, offered value of \$500.00.
  - b. Allotment T777A-C, Section 33, T. 147 N., R. 91 W., Dunn County, 5<sup>th</sup> Principal Meridian of North Dakota, with a 100% Tribal interest, offered value of \$500.00.



**BE IT FINALLY RESOLVED**, that the Chairman is hereby authorized to execute such documents and take such further actions as are necessary to carry out the terms and intent of this Resolution.


**CERTIFICATION**


