



**RESOLUTION OF THE GOVERNING BODY OF THE
THREE AFFILIATED TRIBES OF THE
FORT BERTHOLD INDIAN RESERVATION**

A Resolution Entitled, *“To Authorize the Application and Cost Share Commitment to the U.S. Department of Health and Human Services Administration for Native Americans Social and Economic Strategies Program (SEDS) Grant (FOA #HHS-2018-ACF-ANA-1339)”*

WHEREAS, The Mandan Hidatsa and Arikara Nation (MHA Nation), also known as the Three Affiliated Tribes, having accepted the Indian Reorganization Act of June 18, 1934, the authority under said Act, and having adopted a Constitution and By-laws (the Constitution) under said Act, and

WHEREAS, Pursuant to Article III, Section 1 of the Constitution, the Tribal Business Council is the governing body of the MHA Nation; and

WHEREAS, The Constitution authorizes and empowers the Tribal Business Council to engage in activities on behalf of and in the interest of the welfare and benefit of the MHA Nation and of the enrolled members thereof; and

WHEREAS, Pursuant to Article VI, Section 5(1) of the Constitution, the Tribal Business Council has the power to adopt Resolutions regulating the procedures of the Tribal Business Council, its agencies and officials; and

WHEREAS, Article VI, Section 5(c) of the Constitution specifically authorizes and empowers the Tribal Business Council to administer funds within the exclusive control of the Nation and to make expenditures from available Tribal funds for public purposes for the Nation; and

WHEREAS, The Tribe is committed to developing “food sovereignty” on the Fort Berthold Reservation by implementing indoor growing methods that capture natural gas to provide heat and power to greenhouses; and

WHEREAS, The Tribe is dedicated to providing all the necessary resources, including applying for pertinent grants to plan, develop, and implement a successful Gas Capture Greenhouse Project; and

WHEREAS, The Tribe intends to seek federal grant opportunities with the U.S. Department of Health and Human Services Administration for Native Americans (ANA); and

WHEREAS, The Tribe has been made aware of Funding Opportunity Number HHS-2018-ACF-ANA-1339 (the “Funding Opportunity”) provided by the ANA Social and Economic Strategies Program (SEDS) Grant; and



WHEREAS, The Funding Opportunity is well tailored to assist the Tribe in achieving food sovereignty and establishing indoor growing facilities that are powered and heated by natural gas resources; and

WHEREAS, The Funding Opportunity requires that the Tribe provide a 20 percent match of the total project costs, which is defined as the Tribe's "cost share"; and

WHEREAS, The Tribe intends to submit an application requesting federal funds in the amount of four hundred thousand dollars (\$400,000), a tribal cost share amount of one hundred thousand dollars (\$100,000) for a total project cost of five hundred thousand dollars (\$500,000); and

WHEREAS, The Tribe must affirmatively commit to providing funds for the Cost Share; and

WHEREAS, The Tribe has committed one hundred thousand dollars (\$100,000) to be paid from its FY2020 or FY2021 budget depending upon the contract award date for the Gas Capture Greenhouse Project costs.

NOW THEREFORE BE IT RESOLVED, that the Tribal Business Council of the Three Affiliated Tribes hereby unequivocally commits the one hundred thousand dollars (\$100,000) set aside for food sovereignty and specifically the Gas Capture Greenhouse Project in its FY2020 and FY2021 budgets as funds for the Tribe's Cost Share obligation for the Funding Opportunity; and

BE IT FINALLY RESOLVED, that the Tribal Business Council authorizes the Chairman to submit all necessary documentation to the U.S. Department of Health and Human Services Administration for Native Americans Social and Economic Strategies (SEDS) grant in accordance with this Funding Opportunity.
