



**RESOLUTION OF THE GOVERNING BODY
OF THE THREE AFFILIATED TRIBES
OF THE FORT BERTHOLD INDIAN RESERVATION**

A Resolution entitled, “Approval of Contract with Lexmark Homes LLC to Complete Construction of Two Duplexes for \$295,738.”

WHEREAS, This Nation having accepted the Indian Reorganization Act of June 18, 1934, and the authority under said Act and having adopted a Constitution and By-Laws under said Act; and

WHEREAS, Article III of the Constitution of the Three Affiliated Tribes provides that the Tribal Business Council is the governing body of the Tribes and retains the sole authority to offer limited waivers of sovereign immunity on behalf of the Tribes and their subdivisions; and

WHEREAS, The White Shield/East Segment solicited and received three bids, and on October 1, 2020, approved and accepted the best bid and entered into a *Contractor Construction Agreement* with Lexmark Homes LLC, of Garrison, ND, in form as attached hereto, for the completion of construction of two duplexes in White Shield, MHA Nation (the “Contract”) at a cost of \$295,738; and

WHEREAS, The White Shield/East Segment has a serious shortage of housing for its MHA enrolled members and the two duplexes will help alleviate this need; and

WHEREAS, In order to assure timely payments and completion of the project, White Shield/East Segment requests the approval of the Contract by the Tribal Business Council of the Three Affiliated Tribes.

NOW, THEREFORE BE IT RESOLVED, That the Tribal Business Council of the Three Affiliated Tribes hereby authorizes and approves the *Contractor Construction Agreement* with Lexmark Homes LLC, for completion of construction of two duplexes, in form as attached hereto.


CERTIFICATION


