#### 01. CALL TO ORDER AND OPENING PRAYER:

Chairman Hall called the meeting to order at 11:00 a.m. Gail Baker, a Tribal elder offered a prayer.

Councilman Bird Bear arrived at 12:00 Noon.

# REQUEST TO REPAIR FOUR BEARS MONUMENT LOCATED BY THE MUSEUM: MOTION ONE

Councilman Hale motioned to approve the financial request of to restore the Four Bears monument by replacing the bronze figure at \$5,000 and the fence at \$4,170 for a total of \$9,170 cost of the restoration of the Four Bears Monument from the Economic Recovery Fund. No second, motion failed.

#### 04. TREASURER'S REPORT:

Councilman Wells presented the Treasurer's report.

### 05. APPROVAL OF THE AGENDA: MOTION TWO

Councilman Hale motioned to approve the agenda as amended. Seconded by Councilman Gillette.

Vote: 7 Ayes, 0 Nays, 0 Abstentions, 0 Not voting, Motion carried.

#### 06. APPROVAL OF THE MINUTES:

Councilman Gillette motioned to approve July 13, and 31, 2000, minutes with corrections. Councilman Bird Bear would like to see the minutes corrected prior to approval. No second, motion fails.

#### 07. ADD-ONS:

A. <u>Little Shell Celebration</u>- Amendment to Cap \$28K: RESOLUTION #00-275DSB MOTION THREE

Councilman Bird Bear motioned to lift the \$28K cap to include all segments including Little Shell and amend Resolution #00-192DSB, and to award the Little Shell Pow-wow Committee \$8,000 for cultural activities. Seconded by Councilman Wells.

Vote: 6 Ayes, 1 Nay, 0 Abstentions, 0 Not Voting. Motion Carried.

#### B. Criminal Investigator Resignation:

Homer White Buffalo retired after 26 years of service working for the Tribe. The Tribal Business Council congratulated him for good efforts and wished him well. He thanked the Tribe for the opportunity given him.

- C. Margie Hunts Along MOTIONS FOUR-FIVE
  Tribal elder's tires were slashed while her car was parked at a housing project where she lives in Mandaree. She is asking the Tribe to purchase a mobile home for her to place on her own land.
- D. Councilman Hale motioned to authorize the purchase of a used mobile home between a range of \$6,000-\$10,000 for Margie Hunts Along. Seconded by Councilman Wells.

Discussion: Chairman Hall will develop a proposal to construct 2 homes per segment for the elderly. The proposal will be ready for review on August 28, 2000.

Vote: 6 Ayes, 0 Nays, Abstention, 1 Not Voting. Motion carried.

E. Councilman Hale motioned to compensate Tribal Elder, Margie Hunts Along, in the amount of \$249.60 to replace her slashed tires, seconded by Councilman Wells.

Vote: 5 Ayes, 0 Nays, 1 Abstention, 1 Not Voting. Motion Carried.

F. MOTION FIVE: Gail Baker/Rosemary Mandan Reimbursement:
Tribal Elders tires were slashed by vandals in the Four
Bears Housing Area. Councilman Hale motioned to compensate
Tribal elders, subject to submittal of invoice submitted,
Councilman Wells to follow-up on the Police Report,
seconded by Councilman Wells.

Vote: 5 Ayes, 0 Nays, 2 Abstentions, 0 Not Voting. Motion Carried.

#### 08. <u>OLD BUSINESS</u>:

A. Approval of Tribal Elders Budget: MOTION SIX

The Tribal Elders Organization prioritized a budget for approval for the remaining \$770,000 balance from the \$1 Million dollars appropriated for elders.

MOTION: Councilman Hale motioned to approve the following items: Life Saving Equipment: \$20,000 Eye Glasses: \$20,000 Dentures: \$36,800 Hearing Aides: \$77,000 Handhold Railings, \$69,000 Physical Handicaps (Ramps) @\$60,000.

The Tribal Elders Program will administer the program, develop policy and procedures with the financial transactions processed through Finance Department. Seconded by Councilman Fox.

Vote: 7 Ayes, 0 Nays, 0 Abstentions, 0 Not Voting. Motion Carried.

#### B. <u>ELBOW WOODS WORKS PROPOSAL</u>:

Ed Stewart presented a proposal to build trusses for Twin Buttes Custom Homes. He will bring a proposal back for review. There was no definite date set to bring back the proposal.

C. JTAC BUDGET BALANCES: #6 (2)

The Tribal Business Council directed the Comptroller to format the JTAC budget that will show the actual expenditures, revenue and a balance remaining, also for the 638 Programs, Federal Programs, to include all other Tribal program's carry-over funds, to direct the Tribe to FY01 budgetary matters to help determine any future projects.

  The Tribal Business Council scheduled a meeting on August 28, 2000, at 10:00 a.m., to work on the FY 00/01 budget.

  Councilman Wells directed Myron T. Foote, Tribal Comptroller and staff to provide an up to date financial report for program managers by August 24, 2000. Seconded by Councilman Gillette.

The Tribal Analyst reported that the Retreat is set for September 5, 2000, time will be 10:00 a.m. to 4:00 p.m., at the Four Bears Casino and Lodge. The topics will include: budgets, Personnel station, Reorganization Evaluation, Technology, Future Plans, Inventory lists, administrative structure, salaries/COLA, Departments. Attendees will include Tribal Business Council members and Tribal Managers.

Councilman Fox.

Vote: 6 Ayes, 0 Nays, 0 Abstentions, 1 Not Voting. Motion Carried.

J. <u>United Tribes Technical Education Center Donation:</u>
RESOLUTION #00-279DSB MOTION ELEVEN

Councilman Gillette motioned to approve a monetary gift of \$4000 to the United Tribes International Pow-wow to assist in the promotion of the cultural arts. Seconded by Councilman Fox.

VOTE: 6 Ayes, 0 Nays, 0 Abstentions, 1 Not Voting. Motion Carried.

#### K. Educational Requests:

1. <u>LEONIKA CHARGING</u>: Resolution #00-278DSB MOTION TWELVE Councilman Fox motioned to grant Leonika Charging who is a Law student, an educational grant of \$5,000. Seconded by Councilman Gillette.

Discussion: The Tribal Business Council directed Martha Hunter, Higher Education Director, to devise a 5 Year Payback Plan preparing ways for a payback system. Ms. Hunter is to be present at the August 28, 2000 budget meeting to address the needs of educational requests. Any future educational requests are to be processed through Higher Education Director, who is to be present when these educational grant requests are presented for review.

Councilman Gillette motioned to approve an educational grant of \$1,000 with JTAC Education funds. Seconded by Councilman Fox.

> Councilman Gillette amended his motion to pursue Vocational Educational Rehabilitation Program for assistance, and if he does not qualify under this program, then to authorize a

\$1,000 grant out of the JTAC Education Program. Councilman Fox amended his second.

7. Nanette Twiss Educational Request: MOTION EIGHTEEN
Councilman Wells motioned to approve of an educational grant
for Nanette Twiss of \$3,500 subject to all the documentation
that's required for invoice and for a letter of admission
into whatever school she is enrolled. Seconded by Councilman
Hale.

8. Service Unit Director: MOTION NINETEEN

Councilman Fox motioned that the Tribal Business Council endorse the hiring of James Foote, as the Service Unit Director for the Minne-To-He Clinic, and to send a letter of recommendation to the Aberdeen Area Indian Health Service. Seconded by Councilman Hale.

Councilman Wells motioned to approve the 3 Year NAHASDA Plan submitted by the Fort Berthold Housing Authority. Seconded by Councilman Gillette.

FORT BERTHOLD HOUSING AUTHORITY REMOVED AS THE TDHE: MOTION TWENTY-ONE: Chairman Hall presented a resolution to rescind in its entirety any resolution appointing Fort Berthold Housing Authority as the Tribally Designated Housing Entity (TDHE) for the Three Affiliated Tribes. After a lengthy discussion, this agenda item was deferred until the August 21, 2000 meeting.

  Dennis Huber made a presentation on behalf of Derion Capital Corps. They are a bonding agency.

4. Commodity Warehouse: RESOLUTION #00-281 DSB MOTION TWENTY-

Councilman Hale motioned to approve necessary funding not to exceed \$420,000.00 for the construction of a Commodity Warehouse and office space. Seconded by Councilman Wells.

5. <u>Tribal Expansion Building: RESOLUTION #00-282DSB MOTION TWENTY- FOUR</u>

Councilman Hale motioned that the Three Affiliated Tribes Business Council approve the necessary funding, not to exceed \$450,00.00 for the construction of expanded council chamber and office space. Seconded by Councilman Wells.

6. WELLS NATIONS PROPOSAL: MOTION TWENTY FIVE
Councilman Hale motioned to approve of package #1, subject

VOTE: 6 Ayes, 0 Nays, 0 Abstentions, 1 Not Voting. Motion Carried.

7. NOXIOUS WEEDS: RESOLUTION #00-283DSB MOTION TWENTY-SIX
Todd Hall presented a Resolution for approval that would
declare ten listed weeds noxious. A list of the noxious
weeds is attached to the resolution.

Councilman Gillette motioned to declare the ten listed weeds as noxious. Seconded by Councilman Fox.

8. <u>HUNTING PROCLAMATION #00-284-DSB MOTION TWENTY-SEVEN</u>
Todd Hall, Director of Fish and Game presented a request in resolution form to formulate and publish the respective proclamations annually, according to information gathered from census and studies.

MOTION: Councilman Hale motioned to approve the Hunting Proclamation, and to direct Legal Counsel to include the Figure Four Ranch. Seconded Councilman Wells.

VOTE: 6 Ayes, 0 Nays, 0 Abstentions, 1 Not Voting. Motion Carried.

9. 477 Program RESOLUTION #00-285DSB MOTION TWENTY-EIGHT
Leo Cummings presented a request to establish Youth Resource
Centers in each segment on the Reservation.

MOTION: Councilman Wells motioned to approve funds from the JTAC Competitive Educational Pool funds, in the amount of \$165,000. Seconded by Councilman Hale.

VOTE: 5 Ayes, 0 Nays, 0 Abstentions, 2 Not Voting. Motion Carried.

#### 10. ADD-ON ITEMS: MOTION TWENTY-EIGHT:

Councilman Wells motioned to add on four items, which are: Marilyn and Leonard Baker, LIEHP, and Dorvan White Bear. Seconded by Councilman Gillette.

The firm will make their presentation focusing on the Interpretive Center only. They are to bring materials of murals that will be placed in the Arena, also to revise the concept. Seconded by Councilman Fox.
