05. ELDER'S ORGANIZATION 2002 BUDGET:

The Elder's Organization is advocating for seniors and to provide assistance for independent living. Elders should meet with the Health and Human Resource Committee on December 11, 2001 to rework the budget.

Councilman Wells motioned for approval to allocate an additional \$500,000 for the Elder's Organization for a total of \$750,000 for the 2002 Elder Budget. Seconded by Councilman Gillette.

DISCUSSION: The allocation will be divided from \$300,000 to be taken from the Housing Development line item, \$100,000 from the Land line item, \$50,000 from the miscellaneous line item.

The remaining \$50,000 will be revisited on December 20, 2001 to determine if it

06. <u>THREE DIMENSION IMAGING</u>:

Mr. Jerry Nagel presented a resolution to authorize bidding in township tracts. Mr. Kyle Baker provided a report on oil and gas bids and agreements. Since M3 Energy and the Bureau of Indian Affairs are not available, the Tribal Business Council deferred this agenda item to December 20, 2001 at 11:00 a.m.

07. <u>AMICUS CURIAE BRIEF</u>:

Councilman Gillette motioned for approval to support the Turtle Mountain Band of Chippewa Indians in the case <u>Cass Co. Joint Water Resources District v. 1.43</u> <u>Acres of Land</u>, which is pending in the North Dakota Supreme Court and to direct TAT Legal Department to draft an amicus curiae brief on behalf of the Three Affiliated Tribes. Seconded by Councilman Wells.

VOTE: 7 Ayes, 0 Nays, 0 Abstentions, 0 Not Voting. Motion carried.

08. <u>KIDNEY DIALYSIS UNIT BUDGET</u>:

Councilman Fox motioned to direct KDU to investigate and draft a proposal for additional funding for the Kidney Dialysis Unit with assistance from Hobbs Strauss. Seconded by

Mr. Ronald Little Owl reported on the status of cultural sites and the work that he has performed in the areas of repatriation, ancient site preservation and historical research. Mr. Little Owl is seeking compensation for consultation time (\$2,240) since he is unemployed.

13. FORT BERTHOLD DEVELOPMENT CORPORATION:

Councilman Phelan motioned for approval of amended Resolution No. 01-296-MWJR subject to language change concerning the unconditional guarantee. Seconded by Councilman Fox.

VOTE: 6 Ayes, 0 Nays, 0 Abstention, 1 Not Voting. Motion carried.

14. <u>ROADS MAINTENANCE 638 CONTRACT</u>:

Mr. Nathan Hale provided the Tribal Business Council with a status report on the Roads Maintenance Contract. Road Maintenance failed to follow the correct formula. There must be a Memorandum of Agreement with the counties and State. The total population must be included in transportation issues.

Councilman Fox motioned to change the scope and to prioritize the areas of Lucky Mound and Shell Creek areas before the other areas. Seconded by Councilman Wolf.

VOTE: 7 Ayes, 0 Nays, 0 Abstentions, Not Voting. Motion carried.

DISCUSSION: the Roads personnel are submitting activity reports and the reporting will provide the Tribal Business Council with summaries for detailed information regarding the Roads Department work activities and tracking for 638 and tribal employees. There are 209 miles of Bureau roads and 220 home access roads, some of which are classified as bus routes. Mr. Hale stated that all of Mr.

Councilman Gillette motioned for approval of the restructuring plan of the Roads Maintenance Department, to include the reduction in salary of the Equipment Operator Lead from \$17.75 to \$15.00/hr, and be placed in Twin Buttes, effective immediately and to increase the salary for Administrative Assistant from \$12.75 to \$13.50 retroactive from October 1, 2001. Seconded by Councilman Phelan.

Councilman Phelan motioned for approval to extend Mr. Nathan Hale for an additional thirty days, at the same rate of pay. Seconded by Councilman Wells.
