25. RESOLUTION NO. 05-47-NH, CELESTE WITHAM LAND PURCHASE:

Councilman Spotted Bear moved for approval of the land purchase, exclusive of mineral rights from Celeste Witham, 301-U000494 for a cash consideration of \$117,000, utilizing funds from the Docket 350G Land purchase account and authorizes the Chairman of the Tribal Business Council, its Secretary, and the Superintendent of the Fort Berthold Agency, the Area Director, and Commissioner of Indian Affairs to prepare all documents and to do all things necessary to transfer title of the land to the united States of America in trust for the Three Affiliated Tribes of the Fort Berthold Indian Reservation, to wit: Allot. No. 492A, a 1/1 interest within NET/4 in Section 09, T150N. R90W., Fifth Principal Meridian, North Dakota containing 160.00, acres more or less, which has an actual value of \$93,600.00; and Allot. No. 492A-E, a 1/1 interest within SW1/4SE1/4 in Section 07, T150N.,R90W., Fifth Principal Meridian, North Dakota containing 40.00, acres more or less, which has an actual value of \$23,400.00. Councilman White Calf seconded the motion.

26. RESOLUTION NO. 05-48-NH LAND EXCHANGE TED LONE FIGHT III:

Councilman Spotted Bear moved for approval of the exchanges of land between the Three Affiliated Tribes and Ted Lone Fight III, exclusive of minerals, held in trust by the United States of America for the Three Affiliated Tribes and lands held in trust status by the United States for Theodore Lone Fight III, 301-U2791, hereby authorizes the Chairman of the Tribal Business Council, its Secretary, and the Superintendent of the Fort Berthold Agency, the Area Director, and Commissioner of Indian Affairs to prepare all documents and to do all things necessary to exchange lands for which title is to be transferred to the Tribe and Theodore Lone Fight III. et al under the terms and conditions stated below. Councilman Hale seconded the motion.

Allotment No. 3058, all his interest within the N1/2NW1/4 Section 11, T148N.,R93W.,

Containing a total of 120.00 acres valued at \$18,000.00

Tribal Land:

Allotment No. T1800, all their interest within Lot 1&2, SE1/4Ne1/4 Section 04, T148N. R93W. containing a total of 98.70 acres valued at \$17, 026.00. The Tribe will pay the difference of \$974.00.
