*Discussion: Gilson Mandan we have a facility that holds youth. The younger people don't know how to talk to their children. Feels they don't know proper conduct.*

*Mark N. Fox- we have not received anything back from Aberdeen Area to say we can or we can't. The administrator has to be trained and Mike is at Artesia, New Mexico he is planned to finish in 5 weeks and we should be able to start receiving juveniles in June. Frank Felix makes a suggestion to put Greta Baker on Conference call and ask her why the detention center is not open. Jennifer Fyten wrote a letter already that Mike Young Bird is in training and that the facility will be open with or without him since he is already in training. Mark Fox another letter came in from Greta Baker stating the level of readiness of police officers is in question.*
