

# THREE AFFILIATED TRIBES TRIBAL BUSINESS COUNCIL SPECIAL MEETING NO. 05-13-NH JUNE 03, 2005

#### CALL TO ORDER:

Chairman Tex G. Hall called the meeting to order at 3:30 p.m.

#### ROLL CALL:

Members present: Chairman, Tex G. Hall, Councilman Daylon Spotted, Councilman Whitecalfe, Councilman Packineau and Councilman Nathan Hale. A quorum was established with five members present.

### O1. APPROVAL OF AGENDA:

Councilman Spotted Bear moved for approval of the one item on the agenda as presented. Councilman Whitecalfe seconded the motion.

## 02. MODIFICATION OF RESOLUTION NO. 00-02-DSB, PROVISIONS FOR ALLOCATION OF GRAZING PERMITS ON THE FORT BERTHOLD RESERVATION:

Councilman Hale moved for approval of the modification and to accept the recommendations from the Natural Resources Administrator and staff of the Bureau of Indian Affairs.

### Modification to read:

### A. 50% ownerships -80%Ownership on the unit or Better: (Sub-leasing) Cattle besides own on RU

Pasture Authorization [capacity of the range unit] Acknowledgements of 80% ownership before the next grazing allocation process (06-11)

### B. <u>50% to 10% ownership or less</u>: (Sub-leasing) Just this year's grazing period

Pasture Authorization
Acknowledgement not be eligible for multiple units, only
ne

Authorization to bring in cattle to sub-lease

### C. 10%-0% Sub-leasing:

Pasture Authorization Acknowledgement of 0 in next allocation process
