

THREE AFFILIATED TRIBES TRIBAL BUSINESS COUNCIL REGULAR MEETING NO. 06-07-NH FEBRUARY 13, 2006

RECONVENE MEETING:

The meeting was reconvened at 12:45 p.m. by Vice-Chairman Marcus D. Wells, Jr.

<u>ROLL CALL</u>: Members present: Vice-Chairman, Marcus D. Wells, Jr., Councilman Daylon Spotted Bear, Councilman Frank Whitecalfe, Councilman Mervin Packineau, and Councilman Nathan Hale. Members absent: Chairman Tex G. Hall, (travel) and Councilman Malcolm Wolf. (meeting)

01. <u>REAFFIRM THE AGENDA</u>:

02. <u>RESOLUTION NO. 06-26-NH, BEAVER CREEK CASINO</u>

Councilman Wells moved for approval of a Resolution entitled, "Acknowledgement of Interim non-Tribal Loan and Approval of Fin."

Councilman Whitecalfe seconded the motion.

VOTE: 5 Ayes, 0 Nays, 0 Abstentions, 0 Not voting. Motion carried.

03. DISTRICT TRIBAL JUDGE CONTRACT:

Councilman Whitecalfe moved for approval to extend El-Marie Conklin' contract as the District Tribal Chief Judge with full interim authority until this matter is considered by full council. Councilman Spotted Bear seconded the motion.

VOTE: 5 Ayes, 0 Nays, 0 Abstentions, 0 Not voting. Motion carried.

04. <u>RESOLUTION NO. 06-27-NH-MHA BUFFALO ENTERPRISES, INC.</u> <u>DISSOLVED AND TRANSFERRED TO THREE AFFILIATED TRIBES:</u>

Councilman Hale moved for approval to dissolve the MHA Buffalo Enterprises Inc. and transfer ownership of all assets and liabilities of MHA Buffalo Enterprises to the Three Affiliated Tribes. Councilman Whitecalfe seconded the motion.

Discussion: This action rescinds TBC Resolution No. 03-266-RP

VOTE: 5 Ayes, 0 Nays, 0 Abstentions, 0 Not voting. Motion carried.

05. TRIBAL HOUSING – ELDER HOMES:

Councilman Spotted Bear moved for approval a budget amendment of \$58,000 to replace units that were damaged by natural disaster, which were specifically built for elders in the segments: (1) Four



Bears, (2) White Shield, (2) for Twin Buttes, (2) Parshall and to work with the Legal Department in recouping insurance money. Councilman Whitecalfe seconded the motion

DISCUSSION:

Tribal Housing staff stated they had a run in with TERO regarding not applying fees which would have been an extra cost to the tribe. The director also stressed to the members the units is not free and clear title, and won't be free, its \$150 per month.

VOTE: 5 Ayes, 0 Nays, 0 Abstentions, 0 Not voting. Motion carried.

06. <u>TRIBAL HOUSING - RESOLUTION NOT TO PURCHASE MOBILE HOME FROM</u> CARLA CLARKE:

At the last motion made in January a directive was given to Tribal Housing to purchase the mobile home from Carla Clarke at \$22,000. Councilman Hale reiterated when the full council makes a motion to purchase as was in this case, it should be processed as soon as possible and not scrutinized.

07. <u>BUREAU OF INDIAN AFFAIRS/TRIBAL POLICE CAPTAIN</u>:

Councilman Whitecalfe moved for approval to appoint Nelson Heart, Sr., as the Tribal Police Captain at the same rate of pay he received as the Criminal Investigator and directed him to develop a memorandum of understanding with the Bureau of Indian Affairs. Councilman Packineau seconded the motion.

VOTE: 5 Ayes, 0 Nays, 0 Abstentions, 0 Not voting. Motion carried

Councilman Spotted Bear moved for approval of a Resolution entitled, "Councilman Whitecalfe seconded the motion.

15. 2006 INDIAN GAMING MEMBERSHIP DUES:

Councilman Packineau moved for approval to direct Spencer Wilkinson, Jr. to pay for the membership dues and to take out of the monthly draw from the Casino. Councilman Whitecalfe seconded the motion.

VOTE: 5 Ayes, 0 Nays, 0 Abstentions, 0 Not voting. Motion carried

15. <u>CIRCLE OF LIFE PROGRAM POLICIES AND PROCEDURES</u>

Councilman Spotted Bear moved for approval of a Resolution entitled, "Circle of Life Policy and Procedure Handbook." Councilman Whitecalfe seconded the motion.

DISCUSSION: Councilman Hale stated that Program Directors should be required to present their agenda items and be available to answer any questions the Council may have. The maker of the motion and second were withdrawn until Belinda Beston arrives at the meeting.

18. <u>RESOLUTION NO. 06-32-NH, MANDAREE LAGOON PROJECT – PHASE ONE</u>:

20. <u>ENROLLMENT CLERK</u>:

Councilman Whitecalfe moved for approval to rescind the February 10, 2006 action "to re advertise Enrollment Clerk position, as Nathaniel Mayer was hired in that position permanently. Councilman Packineau seconded the motion.

21. ENROLLMENT CLERK, SALARY INCREASE:

Councilman Whitecalfe moved for approval of a salary increase for Nathaniel Mayer from \$9.00 to \$11.00, as rated by the Human Resources Administrator. Councilman Packineau seconded the motion.

VOTE: 5 Ayes, 0 Nays, 0 Abstentions. 0 Not voting. Motion carried.

22. TRIBAL TOURISM PROGRAM-DAWN CHARGING:

Councilman Hale moved for approval of the ratification of Executive Committee Minutes in which Dawn Charging was hired as the Tourism Director. Councilman Whitecalfe seconded the motion.

DISCUSSION: The Tribal Business Council needs to ratify Executive Committee Minutes of August 2, 2005 and September 20, 2005. Staff hired to work in the Tourism Program are: Scott Eagle, Sherry Gillette, and Crissy Friday and Dawn Charging. Kerry Libby was hired to raise \$100,000 - Karen Patz was hired by the Lewis and Clark Signature Event. AMEND: Back to September 15, 2005.

23. <u>RESOLUTION NO. 06-34-NH FSA REVENUE</u>:

24. <u>CORP OF ENGINEERS GRANT- CULTURAL PRESERVATION, CONSULTANT</u> <u>AGREEMENTS</u>:

Councilman Whitecalfe moved for approval of (2) consultant agreements, 1) Brandon Crows Breast, at \$1500 per month and 2) Perry Brady, at \$1500 per month beginning on October 1, 2005 and ending September 30, 2006; for a total of \$20,000 per consultant. Councilman Packineau seconded the motion.

Councilman Hale moved for approval to hire Ed Hall as a consultant to work on the street lightning. Councilman Packineau seconded the motion.
