

THREE AFFILIATED TRIBES JUDICIAL COMMITTEE MEETING NO. 06-05-NH

Thursday, June 6, 2006

CALLED MEETING TO ORDER:

Chairman Packineau called meeting to order @ 2:00 pm

ROLL CALL:

01. <u>Law Enforcement -Bureau of Indian Affairs- Elmer Four Dance</u>

Memorandum of Understanding between the Three Affiliated Tribes and the Bureau of Indian Affairs for Law Enforcement Services Program within the exterior Boundaries of the Fort Berthold Indian Reservation

CONCERNS:

- Two law enforcement agencies on the tribe
- Coverage of Police Officers in Segments
- Recognition of Newly Hired Police officers
- Liability for the tribe

The Last Judicial meeting the committee instructed BIA Law Enforcement and Tribal Cops Fast Officers to follow the old MOU until the situation is resolved June 6, 2006.

Tribes Duties: Section 2, Page 3

- Provide one (1) vehicle and maintenance cost each of the following segments of the Reservation: Mandaree, White Shield, Four Bears, Parshall and Twin Buttes
- Provide uniforms, equipment, ammunition, gun training/travel expenses for tribal officers
- Require all tribal police officers to possessive valid North Dakota State Drivers License
- Provide that two (2) tribal police officers stationed in each of the following segments Reservation: Mandaree, White Shield, Four Bears, Parshall, And Twin Buttes
- Require that tribal police officers work week holidays, and night shifts, as needed, and provide reasonable compensation for any such time and work
- Be responsible for administering the grant the Tribal Finance Office and/or a representative designated by the Tribal Business Council
- Be responsible for all hiring of tribal officers utilizing the Tribal Personnel and Procedures and minimum law enforcement standards,

- including background investigation be responsible for the termination of employ any tribal police officer, when justified.
- Work with the BIA in the development supplemental tribal personnel police procedure for application to tribal police officers
- Make arrangements with local vendor to provide fuel for patrol cars utilized the tribal officers
- Provide insurance and maintenance on patrol utilized by tribal police officers
- Allow tribal police officers to assist federal, stat, city, and county officers emergency situation, when assistance is required in other areas of the Reservation, or absence of BIA officers
- Assume exclusive liability for tribal officers to the extent provided by any appointment and controlling tribal or federal law.

BIA Duties:

- Provide technical assistance through the Captain Police and the Lead Police officer and ensure that the chain of command will be strictly complied with by each party to prevent fragmented supervision.
- Provide technical assistance to the TAT in the development of supplemental tribal personal policies and procedures for application to the tribe police officers and in the development of day today work assignments with the tribe representative's cooperation.
- Prepare monthly work schedules in conjunction with the tribal representative for all police office
- Provide technical guidance to assure continuity law enforcement activities and administrative responsibilities in cooperation with the TAT
- Provide on-the-job training and in-house training sessions relating to rules and regulations for police offices preparing training schedule conjunction with the tribal representative.
- Coordinate activities for enrolling new tribal police officers in training at the North Dakota State Training Academy in Bismarck, North Dakota with in ONE (1) year from date of selection or available openings, whichever is earlier.
- Assume exclusive liability for BIA police office
- Provide training and certification for all tribal police officers in firearms safety on a semi-annual basis.
