

THREE AFFILIATED TRIBES TRIBAL BUSINESS COUNCIL SPECIAL MEETING NO. 06-21-NH JULY 27, 2006

CALL TO ORDER:

In the absence of the Tribal Chairman, and the Vice-Chairman, Secretary Hale called meeting to order in 3:04 p.m.

03. FY-2006 BUDGET UPDATE; TEMPORARY EMPLOYEES:

Councilman Hale moved for approval of the recommendations from the Financial Team to furlough the non-essential temporary employees with a return date of October 1, 2006; [?] with the exception of essential staff which include: Health, Fire Department, Law Enforcement and water haulers; also to include vehicles and gas charges and give employees an option to keep cell phones but required a \$25.00 pay roll deduction per pay period. Councilman Spotted Bear seconded the motion.

Councilman Packineau moved for approval of a "Resolution amending Resolution No. 06-98-NH" to appoint Mr. Pete Coffee II as Chairman of Election board. Councilman Hale seconded the motion.

VOTE: 5 Ayes, 1 Nay. Motion carried.

06. RESOLUTION NO. 06-104-NH; TRANSFER OF \$1,500,000.00 FROM THE TAT-ECONOMIC RECOVERY FUND TO BANK OF THE WEST.

Councilman Whitecalfe moved for approval of a Resolution entitled, "Directive to the Office of Trust Fund Management to Transfer \$1,500,000.00 from the Three Affiliated Tribes Economic Recovery Fund to Bank of the West." Councilman Spotted Bear seconded the motion.
