

THREE AFFILIATED TRIBES TRIBAL BUSINESS COUNCIL REGULAR MEETING 06-01-VJB NOVEMBER 9, 2006

I. CALL TO ORDER:

Meeting called to order at 10:18 A.M.

II. ROLL CALL:

Councilman Barry Benson, Councilman Frank Whitecalfe, Councilwoman V. Judy Brugh, Chairman Marcus Wells Jr., Councilman Malcolm Wolf, and Councilman Nathan Hale. A quorum is present. Councilman Packineau arrived later.

III. APPROVAL OF AGENDA:

Condolences go out to the Jonie Halsie family out in the Four Bears Segment. She did many things for us. She worked for the secretary's office. She set up the PBX System that we have our internet servers on. Back in 1998 to 2000 she helped get the minutes caught up.

Councilwoman Brugh moved to approve of resolution entitled, "Suspension of Twin Buttes School Board Members, Melissa Starr, Hank Starr, and Darcy Lone Bear and the Temporary Appointment of Colby Little Soldier, Doyle Bell, and Darcy Medicine Stone to the Twin Buttes School." The Motion is seconded by Councilman Hale.

Colby, Doyle, and Darcy will be temporarily appointed until the next election that happens every two years. ISEP funding puts recognition of Indian Schools with the Tribe; this is why the Council can do this.

FY 07' Budget Resolution 06-03-VJB: CFO Brandon Hand Councilman Whitecalfe moved for approval of resolution 06-03-VJB entitled, "Brandon Hand, CFO of the Three Affiliated Tribes be Authorized the Authority to look at the Accounts at OTFM OST in Jim James Office at the B.I.A." The motion is seconded by Councilwoman Brugh.

There is an agreement with Fort Berthold Housing Authority between Four Bears Segment, and Mandaree Segment. They have not moved to extend this to any one else yet but it is there for the housing and the tribe to go together. This is food for thought. This is on residential units. Security is additional help kind of like a neighborhood watch. Parshalls security comes out of their budget. Mervin taked to Dennis Fox at housing about it. Dennis said he would do the \$10,000.00 match but the Tribe owes them. Dennis wanted Mervin to help him get paid then Housing will help out the other segments. How much do we owe? A significant amount.

Discussion: Guns will be taken away depending on the degree of the crime. This has to be developed by the Judicial Committee but this motion is for what is at hand. This is to safe guard the people that are on the Hit List made by a Tribal member not of this reservation. This will be added to the agenda on November 14, 2006.
