I. CALL TO ORDER:

Chairman Marcus Wells, Jr. call to order 10:32 a.m.

II. PRAYER:

Prayer by Councilman Wolf.

III. ROLL CALL:

Members present: Councilman Barry Benson, Councilman Frank White Calfe, Chairman Marcus Wells Jr., Councilman Malcolm Wolf, Councilman Packineau, Councilwoman V. Judy Brugh. Six present, a quorum is established.

IV. APPROVAL OF THE AGENDA:

Councilman Frank White Calfe moved to approve the agenda as amended, motion seconded by Councilman Packineau.

Also the Indian Child Welfare Act old code provisions aren't feasible with regards to the Indian Child Welfare Act. It's a long code of 115 pages and covers mostly everything.
