## I. <u>CALL TO ORDER:</u>

Meeting called to order at 11:20 a.m. by Chairman Marcus Wells Jr. Recess at 1:30 p.m. to move to Tribal Chambers. Meeting reconvened at 2:22 p.m.

Meeting recessed at 7:02 p.m. until 9 a.m.

II. ROLL CALL: Roll Call by Secretary V. Judy Brugh

Councilman Frank Whitecalfe, Councilman Malcolm Wolf (left meeting at 6 p.m.), Councilwoman V. Judy Brugh, Councilman Mervin Packineau, Councilman Barry Benson, Chairman Marcus Wells Jr. A quorum is present. Absent: Councilman Nathan Hale

## III. <u>APPROVAL OF THE AGENDA:</u>

Councilman Whitecalfe moved to approve of the amended agenda, Councilman Packineau seconded the motion.

VOTE: 6 ayes – 0 nay, motion passed.
