VII. ELTON SPOTTED HORSE-ENVIRONMENTAL COMPLIANCE ISSUES

Councilman Whitecalfe moved to authorize the Environmental department to bring the two c-stores, Highway 8 in Twin Buttes and Re-store in White Shield; into compliance with the EPA by getting the tanks tested so they may purchase insurance, seconded by Councilman Packineau.

Discussion: The amount of the testing is \$10,220.00 dollars with the WPC, Inc. (\$7,820.00 bore & testing) (\$2,400.00 pressure testing on lines) (\$3,000.00 6400 gallons lead-free gasoline 3200 gallons diesel). This is for the two stores in White Shield and Twin Buttes. A plan will be implemented for future compliance by the Environmental Department.
