No money has been appropriated for 2008 but will lobby for 2009. He will have a resolution drafted and forwarded to Full Tribal Business Council. He will work with legal on the resolution. Richard will work with Treasurers office to set up a meeting with Dorgan's office to get funding for MHA Systems.
