

THREE AFFILIATED TRIBES TRIBAL BUSINESS COUNCIL SPECIAL MEETING 08-29-VJB

September 24, 2008, 1:00 P.M.

I. CALL TO ORDER:

The Meeting was called to order at 1:30 P.M.

II. PRAYER:

Standing silent prayer.

III. ROLL CALL:

Councilman Barry Benson, Councilwoman Evelyn Hale, Councilman Malcolm Wolf, Councilman Mervin Packineau, and Councilwoman V. Judy Brugh are present. A quorum is established. Councilman Frank Whitecalfe arrived shortly after the meeting started. Chairman Wells Jr. is running one hour late. He arrived at 1:49 P.M.

IV. APPROVAL OF AGENDA:

All reserved at this time.

Councilman Packineau moved to approve of the amended agenda, seconded by Councilwoman Brugh.

Discussion: No discussion.

VOTE: 5 Ayes 0 Nays Motion carried.

V. APPROVAL OF MINUTES:

Deferred to the September 29, 2008 Special Tribal Business Council meeting to be held at the Fort Berthold Community College.

VI. Resolution 08-155-VJB: Upper Missouri River/Tom Fredericks, John Danks, Jonathon Taylor

Councilman Whitecalfe moved to approve of a resolution entitled, "Approval of Letter of Agreement with Taylor Policy Group, Inc. to Provide the Tribes with an Economic Loss Report Regarding Additional Compensation for the Taking of Individual and Tribal Lands within the Fort Berthold Indian Reservation for Construction of the Garrison Dam and Reservoir Project". The motion is seconded by Councilman Packineau.

Discussion: The fee structure is clear. The \$30,000.00 starts right away and then after that it is 12 weeks

for another \$30,000.00, 24 weeks after that it is another \$30,000.00, and after final comments after draft is received is \$10,000.00. This will come out of the general fund. There are two amendments: 1. Amendment to the resolution. 2. Amendment to the agreement. It is self explanatory. Is there going to be a retainer? The \$10,000.00 is a final payment of satisfaction; it will hang out there until the Tribe is satisfied. The retainer is like the \$30,000.00 you get when you sign it. There are two amendments: 1. Amendment to the resolution. In the "Therefore be it further resolved: ("after letter of agreement" add: "attached hereto and Incorporated herein as exhibit A. with Taylor Policy Group, under which Taylor Policy group will provide economic costs") 2. Amendment to the letter of agreement. The TAT legal department will be the point of contact. The Treasurers office will set up a line item for fiscal year 2009. Applicable law will be the state of North Dakota and Tribal law.

Councilman Whitecalfe moved to approve of a resolution entitled, "Three Affiliated Tribes request for fifty surplus bison from Inter Tribal Bison cooperative 2008." The motion is seconded by Councilman Benson.

Discussion: There is enough AUM's out there. This doesn't mean they are getting them. This is just to see if they can be awarded them. This Tribe has to compete with other tribes to get them. The tribe currently has 220 Bison left. VOTE: 5 Ayes 1 Nays (Packineau) Motion carried.

B. Proclamation and Letter of Drought/Feed Assistance

Councilman Packineau moved for approval to send a letter of intent to Gary Nelson the state director of N.D. FSA Office for assistance for the American Indian livestock feed program for Ft. Berthold and to install a proclamation declaring Ft. Berthold

a disaster area for drought, seconded by Councilman Whitecalfe.

Discussion: A proclamation and letter is in

Annette's possession to send.

C. Proceed with Purchase of Land in McLean County

Councilman Benson moved to approve to proceed with a bid for the Emily Hill Estate for 160 acres of fee land at \$850.00 per acre for a total of \$136,000.00, seconded by Councilman Whitecalfe.

Discussion: This land is right in the middle of the reservation by the Episcopal Church in White Shield. The bid has to be in on September 29, 2008 with 10% down and a \$2,000.00 check payable to Haugen Farm Realty, Inc. October 2, 2008 prepare to bid orally with the top five bidders. This just includes land, no minerals. An application to Farmers Home needs to be submitted to help with this purchase.

grant is due this coming week. Monday, September 29, 2008 is a meeting with indirect people and the Chairman.

XV. Northern Star Purchase/Natural Resource Administrator Annette Young Bird

Discussion: For the record, the Northern Star merchandise is appraised at \$60,000.00.

XVI. Resolution 08-158-VJB: Garages on Elderly Complex/200 Conveyances Homes Initiative Proposal/MHA Nation, FBHA, Dennis Fox, Becky Knight

Councilman Wolf moved to approve a resolution entitled, "Request for Funding for Attached Garages for the Project, Hidatsa Homes Elderly Complex". The motion is seconded by Councilman Whitecalfe.

Discussion: What is going on with the Twin Buttes Elder apartments? There was a dispute on the lease between the BIA and the USDA. FBHA has deposited there money on the account. FBHA is waiting on USDA. For the record Councilman Benson asks again about the Elder apartments in Twin Buttes.

The money is right around the corner. Senator Dorgan emailed the chairman regarding the Cherokee that they are using the FBHA as their contact for Indian Country. Senator Dorgan utilizes the notes from the Chairman and Dennis Fox at FBHA. Treasurer asks that Scott Eagle and Dennis Fox will work with him on this to come up with the funding. The mortgages on these will not be too high. Parshall is ready for next year. It is not pushed back. Awarding a bid had been a previous issue. VOTE:

Discussion: There is a lot of need but it is the funding. This will be for Mandaree, White Shield, NewTown, Twin Buttes, and Parshall if they want an officer. If Parshall turns the position down, it will be added to NewTown. Five positions total.

Councilwoman Brugh moved to approve a \$5,000.00 vehicle repair loan for Alicia Grant and Tracy Lewis. The motion is seconded by Councilman Wolf.

Councilman Wolf moved to approve of funding for fiscal year 2009 in the amount of \$200,000.00 for the Early Childhood Center for Ft. Berthold Community College. They are to receive the funding by January 2009. The motion is seconded by Councilman Packineau.

Discussion: They discussed having a meeting in the IVAN room at the college to see what the room is like. The September 29, 2008 Special Tribal Business Council meeting will be held at the Fort Berthold Community College at 1:00 P.M. in the Clan room.

XXV. OBAMA Budget Week Oct. 13-17/Alyce Spotted Bear

Councilwoman Brugh moved to approve the request for Obama Week for \$3,500.00 to the Fort Berthold Community College, seconded by Councilwoman Hale.

Discussion: The poles for voting are closed this

year. All will be by mail.

VOTE: 6 Ayes 0 Nays 1 Abstention

(Packineau) Motion carried.

XXVI. Alona Phelan Medical Request

Councilman Whitecalfe moved to approve a grant in the amount of \$8,000.00 for Alona Phelan Bailey to assist with the medical apartment stay in Denver, Colorado for baby's heart surgery. The motion is seconded by Councilman Packineau.

Discussion: No discussion.

XXVII. Healthcare CEO and Administrator Positions

Councilman Packineau moved to approve to change the contract to say Liaison and to advertise until filled, seconded by Councilman Whitecalfe.

XXVIII. Nichole Wells Military Move Home/Councilwoman Brugh

Councilman Packineau moved to approve \$2,000.00 for Nichole Wells to travel back from the military in Northfield Vermont and then travel to college in Devils Lake North Dakota. The motion is seconded by Councilwoman Brugh.

Discussion: No discussion.

XXIX. Tribal Housing and Fort Berthold Housing Letter

Councilman Packineau moved to reaffirm the positions of Max Dickens as Federal Programs Executive Officer, Laurie Alberts as Chief Executive Officer, and Cammie Gosnell as Programs Analyst. Cammie to evaluate I.H.S. and to oversee the Twin Buttes School Administrator. Seconded by Councilman Wolf.

Special Tribal Business Council Meeting September 24, 2008 Carmen Halvorson

Discussion: The Programs analyst position was created

because two CEO's showed up for work in the Mason

administration.

XXX. New Town Little Shell Annual Leave & Comp Time

Councilman Packineau moved to approve to pay the New Town Little Shell annual leave and comp time, and severance pay. Seconded by Councilwoman Hale.

Discussion: Not to exceed \$5,000.00 x 8
Employees. Severance pay was never paid to Council staff before. Severance Pay based on years in service, \$625 per year not to exceed \$5,000.00. This will be the first time ever that Council's staff will receive severance pay. From this time forward it will be in recognition for years of service. This will be a standard that will be used, to amend the policy handbook. The Council can easily say no to employees but Council doesn't, Human Resources Director commends the Council on this that they help out employees.
