1. CRUELTY TO ANIMALS STARVING

There is a need for enforcement thru Game& Fish, and Law Enforcement. Who would be the assurance of reimbursement of funds to buy 20 bales of emergency feed until we get a hold of the owners to reimburse the Tribe? Who would impose the fine? There is an existing code and nobody puts any hay up but expects the Tribe to purchase hay. Last year the Tribe paid \$94,000 for hay. RECOMMENDATION: NRD and Realty Dept to meet on an informal basis regarding subleasing and bring forward a resolution for recommendation to the full Tribal Business Council.
