VII. Howard Bemer, BIA Superintendent- IMM Hold Accounts

Discussion: on IMM Hold Accounts on Loans, Mr. Howard Bemer stated IMM Account holders need to have small loan approved before account holders are granted a loan on their IMM Accounts.

Can Medicare/ Medicaid have direct access to those funds? No. As far as Child Support, the IMM Accts cannot be garnished on backpay for child support. A hold can be on accounts if payments are not being made.

If no prior permission was made by the BIA on a small loan it can be taken to court that was granted on an IMM Account.

VIII. Lorry Little Swallow/ John J. Rabbithead- Farm Pasture Leases

1. Councilwoman Brugh moved to approve to recognize the Tribe to have majority ownership at 51% on Agricultural Farm Pasture leases, second by Councilman Strahs.

2A. Alan Detienne

RENEWAL for Allot. No. TF001, described as cropland within SW¼, section 29, Twp. 152, Rge. 91 W., Fifth Principal Meridian, North Dakota, containing 126 cultivated acres for the cash rent of \$32.00 per acre, for the total of \$4,032 per year for 5 years.

A residential clause is to be included in this lease.

2B. Harvey Billadeau

RENEWAL for Allot No. T55A/ T82A/ T115A, described as cropland only within E½ SW¼, of section 1, S½ of section 2, section 11, Twp. 148, Rge. 89 W., Fifth Principal Meridian, North Dakota, containing 720 pasture acres for the cash rent of \$10.00 per acre for the total of \$7,200 per year for 5 years.

RENEWAL for Allot. No. T81A, described as cropland only within N½, NW¼, section 16, Twp. 148, Rge. 89 W., Fifth Principal Meridian, North Dakota, containing 68.1 cultivated acres for the cash rent of \$48.00 per acre for the total of \$3,268.80 per year for 5 years.

RENEWAL for Allot. No. T0084/T1320, described as cropland only within SE ¼ of section 12, Twp. 148, Rge. 89 and Lot 1, SE ¼ SW, section 6, Twp. 148, Rge. 88 W., Fifth Principal Meridian, North Dakota, containing 206.4 cultivated acres for the cash rent of \$48.00 per acre for the total of \$9,907.20 per year for 5 years.

RENEWAL for Allot. No. T1298/ T1300, described as Lots 3, 4, & 5, SE ¼, NW ¼, section 6, Twp. 148, Rge. 88 W., Fifth Principal Meridian, North Dakota, containing 127 cultivated acres for the cash rent of \$48.00 per acre for the total of \$6,096 per year for 5 years

RENEWAL for Allot. No. T176A, described as grassland only within Lots 1 & 2, S ½ NE ¼, section 2, Twp. 148, Rge. 89 W., Fifth Principal Meridian, North Dakota, containing 133.22 pasture

acres for the cash rent of \$10.00 per acre for the total of \$1,332.20 per year for 5 years.

2C. Austin Gillette

RENEWAL for Allot. No. Taken Area, described as grass within sections 3, 4, 9, 10, & 11, Twp. 147, Rge. 89 W., Fifth Principal Meridian, North Dakota, containing 446 pasture acres for the cash rent of \$7.50 per acre, for the total of \$3,345 per year for 5 years.

IX. Ed Fox- Land Exchanges/ Landsales/ Homesite

1. Casey Fredericks- Land Exchange (need clear paperwork)

Councilman Strahs moved to approve of the Land Exchange for Casey Fredericks for Allot. No. 2044, second by Councilwoman Brugh.

Discussion: Annette Young Bird is to follow through with getting the land appraised value for value through the BIA. A legal description will be added in to delineate the acreage.

2. Debbie Fox- Land Trade)

Councilwoman Brugh moved to approve of the land trade based on appraisal, value for value of 40 acres of land in the Mandaree area for 40 acres of land in the Shell Creek Area, second by Councilman Strahs.

Discussion: Kenny Stevenson deeded 40 acres of land in the Mandaree area to Debbie Fox to trade with the Tribe for 40 acres of land in the Shell Creek area. Kenny and Debbie's children will inherit mineral rights from the Mandaree land.

Councilwoman Brugh moved to approve, described as Lot 91, Blk. 31, and section 52, Twp. 92, for a total of \$50/ month, second by Councilman Strahs.
