But homes, vehicles you can. Even educational will need to be stopped or cut back. It is at \$2,250.00 per

semester right now. There are two semesters and a summer session per year. It should be limited to \$4,500.00 per year per person.

If their account is at \$3,500.00, they can't get a loan or no loan will be given if loan account is delinquent. The back log of previous loans and payments need to be caught up.
