We notified the Police Department and Terry Gunville and it was a Federal Warrant. He was there for about three weeks there She had visited him earlier and she wasn't afraid of him then., He just ran and jumped the fence One of the Correctional Officers and it is rec time and somebody is that type of character and a danger to some people and if there is a disciplinary action. He probably was cool calm and no problem we do four days in the booking sale.
- For the month of June we had four Federal employees. We received a letter if we had willing to pay \$40@day for five females. Usually we average about 6 females and we only can hold the females and usually our male population is high. Would they be willing to do just females and our male population is fairly high \$40 per day for females. What do they charge \$35 @ day for and everybody has a good time and they are charged. One of the things we are running into problems picked up on a child support warrant and he didn't have a job and he had to stay in jail and it was \$8K and they go to the jail from their jobs. He was making payments every check and child support will not work with us even if are making payments they will have to make the full payments and they don't look at the person trying to make an attempt but they have to pay in full. It depends if the jusdge and they had a warrant and if they only owe that as long as they Ellen runs the program and it's a civil offense and not different and could make payments and its not paid up. Rectified female has been incarcerated and family put mental health have been working with her and the family don; want to take habeas corpus. She also has a legal guardian and we don't see any results. Sadie Young Bird, Case Manager and they work with Will Fox
- We have a meeting on July 7, 2010. My appointment is over tomorrow for acting adult Coordinator and are rated and some action taken probably get a letter tomorrow and ask if Mike Young Bird can be appointed.
