Discussion: Councilwoman Brugh questions why is the tribe getting involved in the tax credit units when it is the Ft. Berthold Housing Authority's responsibility. They should be seeking the funding. The tribe is getting more into debt by putting additional funding into programs that should be self-sufficient. The FBHA Executive Director answered. The application was not put together the way it should have been. Mandan Homes and Hidatsa Homes are still open and the Executive Director wanted them closed first before moving on with other projects but it was already submitted and approved through the state, she couldn't pull herself out of there. While visiting with Raymond James, they were out \$1 million to start with. Who does this? Now it is up to the FBHA to bring all of these and put them all together. Maybe its a million dollars they were short when they did this one. There is an e-mail that says the applications were submitted without the sites being identified. ND State housing took it incomplete. FBHA had to go back in and make all those corrections. After taking a look at it, the FBHA Executive Director realized they were out by a million dollars. There was no way they could get out from under this. The reason FBHA could not get out from under it is because of the investment dollars. If they take this out, then they will not be able to come back in and do any more projects. These are taxable dollars from the state. For the record, FBHA Executive Director is to do a report on the Dream Catcher program funding for the Tribal Business Council reference. VOTE: 6 Ayes 0 Nays Motion carried.

Councilwoman Brugh would like to see more soliciting attempts at getting lower contracts for developing the housing for Elbowoods health facility. Elbowoods Health care Facility Director will work with the Tribal Business Council on more due diligence. This will come out of the general fund or oil and gas funds.

A report was given: Production tax for September 2010 was \$1,041,306.00, Extraction tax was \$600,402.00, and with royalties the oil and gas are bringing in about \$2.7 Million total. There are five wells completed, two wells drilled but are waiting for fracking, one well drilled but needs to be re-drilled lateral on. Petro Hunt is running two rigs but may bring in a third rig. There are thirty-three additional spacing units. Petro Hunt is working on an eighteen mile pipeline. The survey has been completed, right-of-way is to be completed, construction will begin in the spring, and the pipeline will be tied into Bridger Pipeline. The pipeline will be located just off of BIA 30. The ratio is Seven to Eight wells per rig, so next year there will be about fourteen to sixteen wells drilled. They are looking to bring in a third rig to drill second wells in some of the Three Forks units that already have wells. Most of the wells have been in the middle Bakken area. Petro Hunt has about twenty spacing units in the Twin Buttes area that have not had very good results and so they are being evaluated. One well will be drilled to give it a good test and then they will go from there. One well has been drilled west of the casino and another one is being drilled off of highway 23.

Councilman Whitecalfe moved to approve of a proposed agreement with Solstice Energy for the White Shield area acreage. The motion is seconded by Councilman Strahs.

Discussion: A term sheet was given. Councilman Whitecalfe will join Fred Fox and Damon Williams to review the final document. This is a joint development agreement and not a lease, therefore it will have to be reviewed and approved by the B.I.A,

Councilman Whitecalfe moved to approve of a res<mark>olution entitled, "Approval of Existing Oil & Gas Lease held by Spotted Hawk Development, LLC, of McLean, Virginia "("Spotted Hawk")". The motion is seconded by Councilman Packineau.</mark>

Discussion: The total of over payment made in good faith by Spotted Hawk is in the amount of \$204,696.00. Also there was an overpayment on 460 trust acres in the amount of \$22,812.00. Back up will need to be attached to the resolution and a copy of the check. Correction to acreage leased to Spotted Hawk for a total of 4067.25 acres.

11. Resolution 10-114-VJB: 990 acres Lease for Spotted Hawk

Councilman Eagle moved to approve of a resolution entitled, "Approval to leases 990 acres of Lands located in McLean and Mercer County to Spotted Hawk Development, LLC, for Oil and Gas Development on the Fort Berthold Reservation." The motion is seconded by Councilman Packineau.

Discussion: There is an understanding that there is a credit for Spotted Hawk for overpayments in the total amount of \$227,508.00. The \$118,641.60 will come to the tribe (Lease \$346,150.00 –credit \$227,508.00). One well will be drilled within a year. They will also have a minimum of four additional wells drilled prior to the end of their term which is a five year lease. The well "Simba" is producing and a second well is scheduled to be drilled in November 2010. Miya and Golden are 1280's. The 640's will go 2 ½ miles out on the lake bed. Spotted Hawk brought up acreage getting stranded on the lake bed. TAT Legal and the Energy departments worked hard on getting Spotted Hawk, Questar, and Zenergy together to prevent the acreage from getting stranded out there in the middle of the lake. As soon as some of the wells get put in, TAT will move forward on going to court with the state. It will be a long expensive court case. To protect the tribe, just in case, those river bed acreage royalties will be rolling in escrow. This case may take 10 years. There will be a large amount of money sitting in an interest baring account.

Councilwoman Brugh moved to approve to shut down the Ed's bar based on non compliance of an expired business license as being notified by the Chairman of the Four Bears Community Board. The motion is seconded by Councilman Eagle.

Discussion: The memo from the bar owner says: I will accept if you are unresponsive to this request as your approval to run the business. Legal advises the Tribal Business Council; so if we didn't raise the issue back to her, she was putting that out as your extension. It should be the other way around and come from the issuer of the license. Chairman thought that it was shut down until the 28^{th} of September; the tribe received the application for renewal. Either way, it is thumbs up or down. So, it doesn't give anybody the right to avoid the law, or go around the law, or circumvent the law. As of this date, she has filed for renewal and paid the fee. A previous TAT employee states that the issue of the Federal Programs Executive Officer being the bar owner and supervisor of the TAT police needs to be addressed.

The \$75,000.00 is a contingency if there should be any change over's if anything should go wrong with the home. The homes will be switched from Dynamic Homes to SL Construction. No action taken.

N. North Segment Home Initiative Project: Jackie Jackson, H.I.P.

Councilwoman Brugh moved to approve of one home for the North Segment Home Initiative Project. The budget will go through the Home Improvement Program office and the budget will be administered by the H.I.P. Director. The project overseer will be Orville Fox. The motion is seconded by Councilman Strahs.

Discussion: This has been previously approved for the home but is presented again for the approval on the overseer and administrator. The budget will be \$150,000.00 plus \$15,000.00 for contingency. This is tribal funds and not H.I.P. funds.

Councilwoman Brugh moved to approve H.I.P to proceed with the five septic tanks in the Twin Buttes area. The motion is seconded by Councilman Whitecalfe.
