Chairman Tex G. Hall called the meeting to order at 11:26 A.M.

Councilman Whitecalfe moved to approve of a resolution entitled, "Approval of 222 Applicants for Enrollment into the Three Affiliated Tribes." The motion is seconded by Councilman Eagle.

21. Personnel: 477 Cost of Living: Leo Cummings

Councilman Eagle moved to approve of a COLA increase for the 477 Program. This is based on the Budget Management Team approval. The motion is seconded by Councilman Whitecalfe.

24. Resolution 10-010-VJB: Mandaree-West Segment Change of Board Appointments for Commissions, Board of Commissions, and Board of Directors

The changes to the resolution are to change Karan Stevens last name to Rabbithead and to add language to include Karen Rabbithead to Chairman of the Board for FBHA. Both the motion maker and secondary are in concurrence to the two changes.

26. FEMA Trailers: Marvin Danks/Francine White

Councilman Eagle moved to approve of the 19 families listed to receive the FEMA trailers and to tag 10 more with a revolving credit line. The families prioritized to receive the 10 trailers will be based on a point system for the neediest. The motion is seconded by Councilman Whitecalfe.

Discussion: Those that are the neediest should be prioritized. Councilman Eagle is adding onto his list Arlen Fox and Ms. Knutson.

VOTE: 7 Ayes 0 Nays Motion carried.

27. Emergency Management Plan: Marvin Danks

Councilman Whitecalfe moved to approve of a leave of absence for Marvin Danks for 90 Days. He will be working with a couple of oil companies on an Emergency Management Plan. Marvin Danks will be representing the tribe. The motion is seconded by Councilwoman Brugh.

Discussion: The state, County, Roads, State, BLM, Oil companies, Homeland Security, and Corp of Engineers will be incorporated. This will be including all the segments. This will be across the board. Funding will need to be found to develop the plan. Marvin will be paid by the oil companies. The first draft will be out in 45 days. Funding for the man power and resources will need to be sought after.
