MEETING CALL TO ORDER:

Committee Chairman Arnold Strahs called the meeting to order at 2:44 p.m.

ROLL CALL: Committee Chairman Arnold Strahs, Committee member Barry Benson, Committee Member, V. Judy Brugh. A quorum is established with three members present.

APPROVAL OF MINUTES:

Councilwoman Brugh said all unapproved minutes of the Natural Resources Committee will be brought to the next meeting for review and approval.

01. <u>Eagle Rock Timber, Inc</u>. → Rogue Transport:

Councilman Benson moved for approval to forward Eagle Rock's request to the Tribal Business Council Meeting on October 13, 2011. Councilwoman Brugh seconded the motion.

NOTE: *Be so noted that Four Bears Bridge Pit is excluded from the proposal. The Lost Bridge was originally leased to JR Foote, but since the lease has been void. Natural Resource Committee needs to write him a note and tell him to cease taking anything out. Eagle Rock is Native owned and has a few contacts with Reservation companies.

The gravel pit in Shell Creek has been lying undeveloped and the prices are unknown. If the price is locked in— it's good for five years, and rates cannot be adjusted. An Addendum to the lease would be added in the event prices go up.

03. TOM ABE – FBCC/ENVIRONMENTAL & ENERGY ISSUES:

Tom Abe teaches a course in Environmental Science and Research and anatomy Physiology at the FBCC. He involves himself with students' dedicated going into the four year degree program to be more aware of the scope of environmental issues in doing research papers. Interagency Collaborative He will draft a letter of support the NR could submit to open other venues and/or Environmental boards on the reservation. The Environmental Advisory Group would like to present a paper to the council the issues on environmental air quality and what could to be done —good policies with the flairs and explosions.

04. Rural Water Recreation Bulk Distribution Water Commercials Industrial Bulk Contract and Recreation Area Work force Man camp Agreement.

Councilwoman Brugh moved for approval to forward the Industrial Bulk Contract and Recreation Area Work Force Man Camp Agreement to the Tribal Business Council. Councilman Benson seconded the motion.

DISCUSSION: On Page 3 of 3 No. 1: term of 25 years is changed to 5 years. Adjust the price of water – reserve the right for comparable rates.

Bulk is based on the size of the meter, plus \$4.25 per 1,000 gallons of water whatever they use. Discussion on the drain field would like to put in water after the drain field is put in.

VOTE: 3 Ayes. Motion carried.

05. INDIAN HEALTH SERVICE DRAINFIELDS:

Councilwoman Brugh recommended that Bartlett and West be placed on the next Natural Resource Committee agenda to give the committee an updated report. Maynard Demaray informed the committee that B&W did meet with Chairman Hall and staff last week. Committee members said the information was not shared with the Tribal Business Council. The construction of some houses will be finished in a few weeks. Dustin Youpee's drain field has not been dug yet. Laurie Alberts shared a letter from Indian Health Service listing four names authorized to receive drain fields: 1. Tiffany Johnson, 2. Mary Schoppert, 3. Angela Wilson, and 4. Dustin Youpee.

Laurie informed the committee that Shannon and Clover Fox had a major flood in March, 2011 and require a drain field and reported it to Indian Health Service. Their personnel said they went on site but no one was home at the Fox residence so they were by-passed.

Applications were brought over from the Utilities Program and for whatever reason were not forwarded on. Laurie set up a tracking method —scans them in —then sends the application up to Minot so they don't get lost.

She went over a list of applications and gave an update on each one.

No. T26, described as 5.00 Acres within SE1/4SW1/4, Sec. 6, Twp. 149 N, Rge. 90 W. Fifth Principal Meridian North Dakota for 25 years @ \$50.00 per year. Councilman Benson seconded the motion.

Discussion: Original home site has an existing well on 2.5 acres that was Charles Foote. Elsie Foote Hall originally was awarded the home site but she decided to move closer to her parents' home site. The well was originally drilled for Charlie Foote but he chose not to lease—It is 100% tribal land within a 40 acre tract with good well water.

12. MARY & LEONARD HOSIE HOME-SITE/WHITE SHIELD:
