MAY 22, 2012, 10:00 am.**

CALL TO ORDER:

04. Lou Ann Phelan Home Site Lease: Ed Fox

Ed will take this back for a different site.

05. Tom Abe Home Site Lease: Ed Fox

Councilman Benson moved for approval of Tom Abe's home site to be by Mary Jane Bakers home site in Bakers Field. The motion is seconded by Councilwoman Brugh.

VOTE: 3 Ayes. Motion carried.

06. Richard Mayer Land Trade: Ed Fox

Councilwoman Brugh moved for approval of a land trade with Richard Mayer for land described as Allot. No. T3183, Section 22, Township 152 North, Range 92 West. This will go to full Tribal Business Council. The motion is seconded by Councilman Benson.

Motion withdrawn by maker. Annette Young Bird and Ed Fox are to find out if Richard Mayer will move to another spot away from the Taken Area. This will be brought back to the Full Tribal Business Council by resolution.

07. Tom Yellow Wolf Home Site:

08. Water and Sewer Applications: Lorrie Alberts

Councilman Benson moved for approval to add Patricia Lincoln, Tom Abe, Arnold Strahs, and Deanna Romero to the water and sewer applicants. The motion is seconded by Councilwoman Brugh.

09. Archiving Asbuilt Records: Laurie Alberts

11. Rebecca Canyon Elder Basement and Lot Expansion Request: Annette Young Bird, NRD Administrator

This will be referred back to the Housing Improvement Program. She may just have a crawl space and not a basement. She is requesting a cement basement and not a wood basement. An application will need to be filled out for a lot modification.

12. Amos Hindshaw Land Sale:

Councilwoman Brugh moved for approval for Amos Hindshaws .95 acre land acquisition. This will be forwarded to Full Tribal Business Council. The motion is seconded by Councilman Benson.

13. Test America Route 14 Road Sample

Councilwoman Brugh moved for approval for Test America to go forward with their Road sample on Route 14. This will be in the Raymond Yellow Wolf area. Test America is to coordinate with Curt Wells in the Three Affiliated Tribes Roads Department. The motion is seconded by Councilman Benson.

VOTE: 3 Ayes. Motion carried.

14. ADJOURNMENT:

Councilwoman Brugh moved for approval to adjourn the meeting. The motion is seconded by Councilman Benson.
