CALL TO ORDER:

Councilman Packineau called the meeting to order at 1:25 p.m.

ROLL CALL:

<u>Present</u>: Councilman Packineau, Councilman Eagle and Councilwoman Brugh.

Law Enforcement, Domestic Violence, Gerald Tex Fox Justice Center.

01. INVOCATION: All attendees observed a moment of silence.

02. APPROVAL OF AGENDA:

Councilman Brugh moved for approval of the agenda as presented.

Councilwoman Eagle seconded the motion.

VOTE: 3 Ayes, unanimous.

03. DOMESTIC VIOLENCE:

- » Temporary Appointments
- » Out of compliance with grant
- No office space no confidentiality currently residing in the Social Service Department. Water in Sanish now Jerry Nagel donated one lot for Domestic Violence Program. Six lots cistern \$18,000 and septic total \$36,000.
- » **ZONING CODES**: there is a lot between the Social Services office and we have to buy one. Did the council give \$ for the program. Dennis Fox will be directed to look for funds to apply to program.
- » Indian Health Service vacant offices available? Usable? Maintenance to renovate them. Future to look for Northern Star.

AUDREY DAVY BUILDING:

Scott Eagle moved to request an expert opinion on the old Audrey Davy Building. Hire a company that will access the "old Social Service" building on asbestos. Councilwoman Brugh seconded the motion.

Councilman Eagle will put together a proposal on refurbishing and bring it to the July 12, 2012 meeting.

VOTE: 5 Ayes. Motion carried.

O4. SAFE HOUSE LOCATED AT PARSHALL RESOURCE CENTER: PRC/DV purchased a FEMA Home to use it as a "Safe House, transient housing. Rent? Collection of rent. NRC. 94 clients First high school Domestic Violence prevention. Teen dating club 30 teams to utilize the Jack Barter Center – brought it back the last two weeks. Quarterly for Healthy Relationship. Elder Abuse ? Code? Legal to work with D.V. covering it under the Domestic Violence.

VOTE: 3 Ayes. Unanimous.

05. **GAME AND FISH BUILDING**:

The Game and Fish Program will be expanding their building with the one that is adjacent to the building. It is located right besides the bank. Dismantle it and move to North Segment. Cost? Approved for \$8K.

06. **LAW ENFORCEMENT**: Blaine Flynn

Councilman Eagle moved for approval to place Diana Good Luck on administrative leave until a decision is decided regarding her employment with the Gerald Tex Fox Justice Center. Councilwoman Brugh seconded the motion.

VOTE: 3 Ayes. Motion carried unanimously.
