

# THREE AFFILIATED TRIBES TRIBAL BUSINESS COUNCIL REGULAR MEETING 12-29-TGH SEPTEMBER 27, 2012, 10:00 am.

#### **CALL TO ORDER:**

Chairman Tex G. Hall called the meeting to order at 11:43 am.

#### PRAYER:

Councilman Eagle gave the invocation.

#### **ROLL CALL:**

**Present**: Tribal Chairman Tex G. Hall, Councilman Frank Whitecalfe, (telecom.) Councilman Scott Eagle, Councilman Mervin Packineau, and Councilwoman V. Judy Brugh. **Absent**: Councilman Barry Benson (sick), Councilman Arnie Strahs, (death in family.)

#### I. APPROVAL OF AGENDA:

Councilman Eagle moved to approve the agenda as set. Councilwoman Brugh seconded the motion.

VOTE: 6 Ayes. Motion carried.

### II. RESOLUTION NO. 12-101-VJB – APPOINTMENT OF FRED FOX— WHITE SHIELD REPRESENTATIVE SWEARING IN/OATH OF OFFICE:

Councilman Packineau moved to approve the appointment of Fred Fox as the White Shield Representative from this date to November 6, 2012 where he will be sworn in November, 2012. Councilman Eagle seconded the motion.

VOTE: 6 Ayes. Motion carried.

#### III. ACCEPTANCE OF RESIGNATION LETTER WHITECALFE:

Councilman Eagle moved to accept a resignation letter from Frank Whitecalfe as the White Shield Representative. Councilman Packineau seconded the motion.

VOTE: 5 Ayes. Motion carried unanimously.

#### IV. MARILYN JACOBS FINANCIAL REQUEST:

Councilman Packineau moved to approve a financial request from Marilyn Jacobs to repair an electrical box located in her home estimated cost is \$3,875. Councilwoman Brugh seconded the motion.

VOTE: 6 Ayes. Motion carried unanimously.

#### V. APPROVAL OF AUGUST 09, 2012 MINUTES:

Councilman Eagle moved to approve the Minutes of August 09, 2012. Councilman Packineau seconded the motion.

#### VI. RESOLUTION NO. 12-100-VJB -FIRE MANAGEMENT: FINAL READING:

Councilman Eagle moved to approve a Resolution entitled, "Adoption of the Three Affiliated Tribes Fire Protection Code." Councilman Packineau seconded the motion.

VOTE: 5 Ayes. Motion carried.

#### VII. CHAIRMANS REPORT: Tex G. Hall

#### A. RESOLUTION NO. 12-101-VJB

Councilman Eagle moved to a Resolution entitled, "Appointment of Fred Fox to Fill the Unexpired term of White Shield Councilman Whitecalfe." Councilman Brugh seconded the motion.

VOTE: 5 Ayes. Motion carried.

NOTE: On September 21, 2012 Frank Whitecalfe resigned from his position as the Councilman for the White Shield segment and pursuant to Article III, Section 6 of the TAT Constitution Whitecalfe term expires upon the next Regular Election, November 6, 2012. Fred Fox received over 51% of the votes in the primary election for the next White Shield councilman, and is therefore deemed the successful elected candidate to fill the next 4 year term for the White Shield representative pursuant to Article IV, Section3,  $\bigcirc$  and (e) of the Constitution to begin following the November 6, 2012 general election. The Tribal Business Council hereby appoints Fred Fox to assume the remainder of the term vacated by Frank Whitecalfe as Councilman for the White Shield Community.

VOTE: 5 Ayes. Motion carried unanimously.

**B. RESOLUTION NO. 12-102-VJB**, "Request to the Bureau of Indian Affairs, Great Region Division of Transportation that EFRO Funding be contracted to PL 93-638."

Councilwoman Brugh moved to approve a Resolution entitled, "Request to the Bureau of Indian Affairs, Great Region Division of Transportation that EFRO Funding be contracted to PL 93-638." Councilman Packineau seconded the motion.

VOTE: 5 Ayes. Motion carried.

**C. RESOLUTION NO. 12-103-VJB,** "The Oil and Gas Structure Setback Act." Councilman Fox moved to approve a Resolution entitled, "The Oil and Gas Structure Setback Act." Councilman Packineau seconded the motion.

NOTE: The Nation recognizes the need for balanced laws that protect both the interest of property owners and the business interest of Oil and Gas Companies. Well pads, well heads, waste pits, reserve pits, oil storage tanks, and oil pumping units shall not be located within 2,640 feet (1/2) mile of an occupied residence, tribal building, school, hospital, or other structures where people are known to congregate.

A property owner and an Oil and Gas Company may contract to locate any of the above mentioned oil production structures within 2,640 feet (1/2) mile of an occupied residence, tribal building, school, hospital, provided that the Oil and Gas Company provide adequate compensation to the property owner for the close proximity of the oil production structure, and provided further that the interest of other property are not encroached by a distance less than the setback requirement.

Any company found to be in violation of this resolution shall be fined up to One Million (\$1,000,000) under the Nation's Civil Code in addition to possible revocation of this TERO License and any such other Tribal licenses the company may hold.

C. <u>FORT LARAMIE TREATY</u> "Tribal Sacred and Ceremonial Ride." Councilman Eagle moved to approve a budget Plan C of \$49,200.00 to fund the Fort Laramie Treaty "Tribal Sacred and Ceremonial Ride." Councilman Fox seconded the motion.

VOTE: 5 Ayes. Motion carried.

### D. RESOLUTION NO. 12-104-VJB RECOMMENDATION FOR DELVIN DRIVER, JR. AS NATIVE AMERICAN LANGUAGE INSTRUCTOR.

Councilman Eagle moved for approval of the recommendation for Delvin Driver Jr. as a Native Language Instructor." Councilman Packineau seconded the motion.

VOTE: 5 Ayes. Motion carried.

**E.** RESOLUTION NO. 12-105-VJB, "2012 PRESIDENTIAL ENDORSEMENT OF BARACK OBAMA: Councilwoman Brugh moved to approve a Resolution entitled, "2012 Presidential endorsement of President Barak Obama." Councilman Fox seconded the motion.

VOTE: 5 Ayes. Motion carried.

#### F. APPROVAL OF BUDGET FOR OBAMA CAMPAIGN:

Councilman Eagle moved to approve a grand total of \$11,550 to the Campaign to re-elect President Barak Obama. Councilwoman Brugh seconded the motion.

VOTE 4 Ayes, 0 Nays, 1 Abstention

#### G. RESOLUTION NO. 12-106-VJB, NORTHWEST AREA FOUNDATION GRANT

Councilman Eagle moved to approve a Resolution entitled, "Northwest Area Foundation Grant." Councilman Packineau seconded the motion.

VOTE: 5 Aves. Motion carried.

NOTE: The Tribal Business Council hereby approves applications to the Northwest Foundation for funding for the "MHA Nation Tomorrow Project."

IX Sec. 3A (5) of the Charter to fill the five vacancies on the Health Authority Board of Directors.

#### **CODY BRUGH SPONSORSHIP**

**A.** Councilman Packineau moved to approve a \$2,000 sponsorship to Cody Brugh to participate in the National Indian Rodeo Finals, with the funding to come out of TBC Actions. Councilman Fox seconded the motion.

#### B. FATIMA FINLEY SPONSORSHIP MARATHON RUN:

Councilman Packineau moved to approve a \$2,000 sponsorship to Fatima Finley to participate in a Marathon Run, with the funding to come out of TBC actions. Councilman Fox seconded the motion.

VOTE: 5 Ayes. Motion carried.

#### C. CONTINUING RESOLUTION OCTOBER. 1, 2012:

Councilman Packineau moved to approve a Continuing Resolution at a rate being at the same as fiscal year 2012 budget, until after the Three Affiliated Tribe approves the FY-13 budget. Councilwoman Brugh seconded the motion.

VOTE: 5 Ayes. Motion carried.

#### D. RESOLUTION NO. 12-108-VJB: BOYS AND GIRLS ORGANIZATIONAL:

Councilwoman Brugh moved to approve a Resolution No. 12-108-VJB. "Authorization for the Boys & Girls Club of the Three Affiliated Tribes to partner with the University of Colorado American Indian and Alaska Native Program to implement the "Teen Pregnancy Prevention among Native Youth research study." Councilman Fox seconded the motion.

VOTE: 5 Ayes. Motion carried.

#### E. MHA ELDERS ORGANIZATION:

Ramona Two Shields questioned why the electronic voting process was not used in the primary election. Joe Myrick, Election Board Chairman said the machines malfunctioned. More discussion on training and if machines malfunction to demand a new machine. It needs to be approved by the 18th.

#### **F. TRAVEL AGENCY:** Jody Fox

Jody Fox presented a proposal to implement a travel agency proposal into operation for the Tribe. Her fees would be monthly negotiable \$3900 and would put an office in the tribal administration office for one month.

The tribal business council decided to give Jody Fox a chance to prove her capabilities. A office will be set up for her to begin operations.
