

# THREE AFFILIATED TRIBES TRIBAL BUSINESS COUNCIL JUDICIAL COMMITTEE MEETING NO. 13-01-JRP JANUARY 09, 2013

### **CALL TO ORDER:**

Committee Chairman J. Randy Phelan called the meeting to order at 1:16 pm.

### PRAYER:

Kenneth Hall gave the invocation.

### **ROLL CALL:**

**Present**: Committee Chairman, Jude Randy Phelan – Committee member V. Judy Brugh and Committee member L. Kenneth Hall. Tribal Court staff, Law Enforcement staff,

### **APPROVAL OF AGENDA:**

Reserve action items Department Reports. The committee requested the latest update on Drug Task Force.

### FORT BERTHOLD TRIBAL DISTRICT COURT:

- Domestic Violence Court was in operation until December 31, 2012, whereas confusion
  on the budget was no longer funded. Sadie Young Bird didn't submit a budget because
  they were told grant specifically docket for court.
- Ms. Judy Blackhawk was appointed as Judicial Administrative Assistant.
   Court Administrator position was recommended by top management
   Norma Baker, December 2012.
   Restructure Court system: Bring in a transition team and will need assistance working with ND Supreme Court and Jim Fitzsimons.
- Law Enforcement component and citations are in place.
- Correction Center is another component.
- Once we start this –all Programs are going to effect and;
- Jails are overcrowding and have been extremely busy
- Released inmate that was one week short of one week because the Jail overcrowding.
- Put Court dockets in the paper as well as the arrests in the paper.
- This request will come from the judicial committee. Drug users moved in communities and we now live in a dangerous environment and era.
- Serious problem with meth users.
- We will have legal do an opinion before court dockets is put it in the papers when they are charged. Codify it and use some perimeters on spell it out if they are going to be convicted. Combat drug usage.

## **CHILD SUPPORT DIVISION:**

Names of members who are delinquent with child support will be put in the Tribal newspaper. Hopefully it's going to open up minds. It was not in the Judicial Code... there was no motion from the committee:

PASS TO TBC subject to working with Tribal Court. They explained the transparency. Draft a section amending the Judicial code part of tribal law.

MOTION: Councilman Ken Hall moved to approve the recommendation of the judicial programs to print the names of people who were incarcerated with their charges; also to put the names of people in the local papers that are behind in their Child Support payments. Councilwoman Brugh seconded the motion.

DISCUSSION: Everyone in the meeting agreed with the transparency to be pro-active and all on the same page look out for the best interest in everybody involved. Possibly the young people will realize the shame combat this drug use in a positive Way.

VOTE: 3 Ayes. Motion carried.

Redirect drug related offenses and model our court working on Judge McGladly to work out MOA with other programs.

Change the Drug Laws on the reservation that will include longer jail sentences.

Counseling while incarcerated. Being drained now going to tax the court system.

We need Counselors for Meth users.

Invite the Judicial committee to visit the court system to see firsthand send schedules and share with the rest of the counselors.

Recommend other court systems higher court fees for cost, time and effort.

Non-Indian came and paid the \$25 fees: Over 500 K assigns 3 people to work on the fines and costs. Why should the Court system sit on court fees? Fee for LE make arrest for fees to come back to their stem LE. If are fined and plead guilty \$ generated will go back to programs. % of the money goes back to court systems. Fines and Cost Budget used for operation of Tribal Court.
