# **02. DOMESTIC VIOLENCE PROGRAM:** Sadie Young Bird

Sadie Young Bird introduced official from Washington, D.C. She explained the Application process to apply for the Domestic Violence Pilot Program. The initial meeting in August— where representatives from different tribes to sit on the working group cooperate with other agencies.

# 04. FORT BERTHOLD COURT Report Judge Diane Johnson:

Judge Johnson US Dept of August 8, 2013 Court Administrator coordinated present testimony on the Drug trafficking on Fort Berthold.

TAT has only 1 Probation Officer @200 clients and want to hire 4-5 staff. Increase in penalty Statutues draft resolutions for the Judicial Committee haven't been out out on the comment period. Asking the TBC to waive the comment period. There will be a Federal presence here on the Reservation August 8, 2013 to review and support

MOTION: Councilwoman Brugh moved to recommend approval to waive the 30 day comment period to Increase in Penalty Statutue with justification being TAT already declared war on drugs. Councilman Hall seconded the motion.
