

THREE AFFILIATED TRIBES TRIBAL BUSINESS COUNCIL ECONOMIC DEVELOPMENT COMMITTEE REGULAR MEETING NO. 13-01-LKH JULY 17, 2013

CALL TO ORDER:

Committee Chair Councilman Ken Hall called the meeting to order at 10:55am.

PRAYER: Councilwoman V. Judy Brugh gave the invocation.

ROLL CALL: Present) Councilman Ken Hall, Councilman Fred Fox, and Councilwoman Judy Brugh. A quorum is established with three members present.

01. APPROVAL OF AGENDA:

Councilman Fred Fox moved to approve the agenda as presented. Councilwoman Judy Brugh seconded the motion.

VOTE: 3 Ayes. Motion carried.

02. APPROVAL OF MINUTES:

Councilman Fred Fox moved to approve the Minutes of June 26, 2013 with corrections. Councilwoman Judy Brugh seconded the motion.

03. EDUCATIONAL REQUEST:

FLY-IN PROGRAM:

Councilman Fox moved to approve a \$3,000 request from Cesar Alvarez for the Fly-In Program with Harvard University Native American Program (HUNAP) and forward to full Tribal Business Council on July 11, 2013 for action. Councilwoman Brugh seconded the motion.

VOTE: 3 Ayes. Motion carried.

EDUCATIONAL TRUST FUND: Cesar Alvarez gave an overview of Educational Trust Fund plan, to look into non-disclosure —expand what is in place to enhance students who are tapped out of funding. Martha Hunter will help to coordinate the non-disclosure.

Councilman Fox moved to forward to the August 11, 2013 Tribal Business Council recommending an Education Trust Fund criteria with a percentage of the Peoples Fund. Councilwoman Brugh seconded the motion.

NOTES: To do the Research by reaching out to other tribes who are very willing to work with us. Southern Ute has a Trust Fund for Education they don't give out Per Capita. College is free Elders don't get any money.

Affect higher Ed. Student Loans: Try to keep at the Pell Grant \$300,000 thanks to Ken got additional funds. Scholarships not even enough. Tribe gave Higher Ed. to pay back People Fund percentage to Education

04. MASSNUTTEN MILITARY SCHOOL REQUEST: KATIE DECOTEAU11:46:38

Kelly McGrady is requesting financial assistance from the Tribe of \$31,500 tuition for her daughter Katie Decoteau to attend Military Prep School.

Councilwoman Brugh motioned to have Kelly McGrady work with Damon Brady, Martha Hunter, Cesar Alveraz and Roger White Owl, Sr., to work on outside guidelines for high school students Needs and to bring back to the Tribal Business Council. Councilman Fox seconded the motion.
