So it is critical that the clinic passes the accreditation and review AAAC.

B. <u>**PEOPLES FUND**</u>: By-laws Eligibility criteria \$180 million has been invested and Tribe will be using interest for a pay-out in August or September 2014. They will report to TBC draft on Jan 1, 2014. Next Meeting is Oct. 23, 2013. Agenda will be updated need a budget and a Director people will flood someone and work closely with enrollment.



C. RESOLUTION NO. 13-162-VJB ELECTION BOARD:

Councilman Fred Fox moved to approve Resolution No. 13-162-VJB, and to increase pay rate of members by \$1.00. Councilman Mervin Packineau seconded the motion.
