

THREE AFFILIATED TRIBES TRIBAL BUSINESS COUNCIL SPECIAL TRIBAL BUSINESS COUNCIL MEETING 13-17-TGH DECEMBER 17, 2013 12:00 P.M.

CALL TO ORDER:

In the absence of Chairman Tex G. Hall, Vice-Chairman Fred Fox called the meeting to order at 12:00 pm.

PRAYER: Councilwoman Judy Brugh said the invocation.

ROLL CALL:

Present: Vice-Chair Fred Fox, Councilman Ken Hall, Councilwoman V. Judy Brugh and Councilman Randy Phelan. Councilman Mervin Packineau (teleconference.) Absent: Chairman Tex G. Hall due to travel and Councilman Barry Benson. A quorum is established with five members.

01. APPROVAL OF AGENDA:

Councilman Ken Hall moved for approval of the one item agenda. Councilman Randy Phelan seconded the motion.

VOTE: 5 Ayes. Motion carried.

02. <u>RESOLUTION NO. 13-184 -VJB—AUTHORIZATION FOR A ONE TIME</u> HOLIDAY DISBURSEMENT FROM EACH REPRESENTATIVE'S HOUSING FUNDS —TO ALL ENROLLED MEMBERS OF THE THREE AFFILIATED TRIBES:

Councilman Phelan moved to approve Resolution No. 13-184-VJB, entitled, "Authorization for a 'One Time Holiday Disbursement" —paid from Housing Allocation Representatives line item —to all enrolled Members of the Three Affiliated Tribes." Councilman Ken Hall seconded the motion.

Councilman Randy Phelan moved to approve a temporary 30 day appointment for Evelyn Akipa as Public Defender. Councilman Ken Hall seconded the motion.
