

## THREE AFFILIATED TRIBES TRIBAL BUSINESS COUNCIL MEETING NO. 04-04-2014-TGH FEBRUARY 28, 2014

## RECONVENE MEETING/CALL TO ORDER:

In the absence of Tribal Chairman, Tex G. Hall, Vice-Chairman presided over meeting and called it to order 11:15 am.

**ROLL CALL: Present:** Vice-Chairman Fred Fox, Councilman Randy Phelan, Councilman Barry Benson, Councilman Ken Hall, and Councilwoman Judy Brugh. **Absent:** Chairman Tex G. Hall (On official travel) Councilman Mervin Packineau (Family Health.)

INVOCATION: Councilman Randy Phelan said the invocation.

### 01. CONTINUATION OF AGENDA—CHIEF FINANCIAL OFFICER:

#### A. DREAM CATCHER HOUSING—: PURCHASE PRICE FORMULA:

Councilman Randy Phelan moved to approve the "Purchase Price Formula for the Dream Catcher Homes." Councilman Barry Benson seconded the motion.
