

THREE AFFILIATED TRIBES TRIBAL BUSINESS COUNCIL REGULAR MEETING 14-06-TGH April 10th, 2014 10:00 a.m.

CALL TO ORDER:

Chairman Tex G. Hall called the meeting to order at 11:50 am.

PRAYER:

ROLL CALL:

Present: Councilman Fred Fox, Councilman Barry Benson, Councilman Randy Phelan, Councilman Ken Hall, Councilman Mervin Packineau and Councilwoman Judy Brugh.

I. APPROVAL OF AGENDA:

Councilman Randy Phelan moved to accept the agenda as amended. Councilman Ken Hall seconded the motion.

VOTE: 6 Ayes. Motion carried.

Amendment: So noted include the Four Bears Classic/Ray Poitra request.

II. APPROVAL OF MARCH 27, 2014 MINUTES:

Councilman Randy Phelan moved to approve the Minutes of March 27, 2014 as amended. Councilman Ken Hall seconded the motion.

VOTE: 6 Ayes. Motion carried.

III. SPECIAL GUESTS/ELDERS:

UNFINISHED BUSINESS:

A. MOTION ONE-THUNDER BUTTE OIL REFINERY, \$200 MILLION BOND:

Councilman Fred Fox moved to approve PRO-Forma Cash Flow and Debt Calculations \$200 Tribal, and to authorize and approve the bank financing model. Councilman Mervin Packineau seconded the motion.

VOTE: 5 Ayes, 1 Opposed. Motion carried. (FTR) Councilman Randy Phelan opposed the motion.

B. MOTION TWO- THUNDER BUTTE OIL REFINERY PAYMENT SCHEDULE:

Councilman Mervin Packineau moved to approve the Thunder Butte Oil Refinery Payment schedule and to work the Finance Office and the Chief Financial Officer. Councilman Fred Fox seconded the motion.

VOTE: 4 Ayes, 2 Nays. Motion carried.

(FTR) Councilman Randy Phelan opposed the motion.

C. MOTION THREE: THUNDER BUTTE OIL REFINERY CORVAL GROUP, OSBL ENGINEER:

Councilman Mervin Packineau moved to approve a Resolution entitled, "Designation of Qualified Expert Witnesses on ICWA cases. Councilman Ken Hall seconded the motion.
