

THREE AFFILIATED TRIBES TRIBAL BUSINESS COUNCIL REGULAR MEETING NO. 14-07-VJB May 19th, 2014 11:00 AM

CALL TO ORDER:

Chairman Tex G. Hall called the meeting to order at 11:04 AM.

PRAYER:

Keith Bear gave the invocation.

ROLL CALL:

Present: Chairman Tex G. Hall, Councilman Ken Hall, Councilman Berry Benson, Councilman Randy Phelan, Councilman Mervin Packineau, Councilman Fred Fox and Councilwoman V. Judy Brugh are present. A quorum is established with all members present.

Ed Hall did a presentation on Demographic and Socioeconomic Profile. "Tribal Health Care Insurance Plan for all tribally enrolled members. Consults are Shelby Consultants.

1. RESOLUTION NO. 14-074-VJB:

Councilman Randy Phelan moved to approve a Resolution entitled "Payne West Insurance for \$30,000 approving a contract to facilitate a process that will clarify and define best practices for payment of Health Insurance for all tribal members both on and off the reservation by the MHA Nation." Councilman Fred Fox seconded the motion.

VOTE: 7 Ayes. Motion carried.

Presented the resolution entitled "Approving contract with Revolution Advisors to develop a Reservation Management System (RIMS) for the Fort Berthold Reservation" Councilwoman Judy Brugh noted that the Legal Department has not sent it to the Executive Secretary Office. Chairman Tex G. Hall stated that the contract could still presented for approval at this time.

Councilwoman Judy Brugh motioned to approve a contract with RIMS for \$17,000.00, with a Resolution to follow. Councilman Ken Hall seconded the motion.

The stone finish is \$32.20 per square foot and the brick is \$35.00 per square foot.
