II. NEW BUSINESS:

A. Northern Star Gift Shop

A summary Report was submitted by Programs analyst, Cheryl Bruce.

The fiscal year 2013-2014 ended at \$304,301.74 in total sales with operating expenses of \$303,659.14 and payroll at \$93,985.36 leaving a profit/loss of -93,342.76.

Issues that are outlined in the report include reports presented that no not reflect true and accurate expenses, procedure of purchasing and tracking inventory, and payroll expenses and staffing.

Remedies presented include providing a comprehensive monthly report, implementing a consignment from artist, and restructuring of staff.



No Tribal Business Council action was taken on this item however, Tribal Council did advise that the Northern Star Gift Shop needs to work with the North Segment Community Development Corporation as the Northern Star Gift Shop is now under the supervision of the North Segment.

B. Four Bears Casino

The Four Bears Casino Manager, Patrick Wilkinson presented the company, Rubert, the consultant company for the Food Services for both the Bison Room as well as the Buffet. Also presented was the design company, KLJ who provided the Tribal Council with an update on the status of the Four Bears casino's renovation projects.

Motion: Councilman Mervin Packineau moved to approve Resolution #15-006-CSB entitled "Approval of the Construction Loan Agreement, Disbursing Agreement, Reimbursement Agreement for the Renovation of the Non-Gaming Area, and the Promissory Note of the Construction Loan for the Four Bears Casino" with the amendment to include the stipulation that the loan would not exceed \$47 million dollars. Motion seconded by Fred Fox seconded the motion.

FTR: Councilman Fred Fox stated that he would like to note that he does not agree with the Committees not having authority for final approval on the items presented at committee level. He understands the policy of having the Tribal Business Council's approval but would like to stat that he does not agree with the policy.
