FTR: Chairman Mark N. Fox welcomed the audience and especially the elders. He commented on the success of the Little Shell Celebration and is anticipating the upcoming Four Bears Pow-Wow. The Tribal Business Council had a budget work session vesterday and will finalize it by October 2015. Discussion of getting a statement correct on the Tribes end. Chairman Mark N. Fox discussed activities in Washington, DC, and working with the Corps of Engineers for the return of lands. Also discussed the Cobell Buy Back program and the low rates that the program is offering at Fort Berthold and the need to increase these rates to be commensurate with the true value of the land. We will be doing a broad based report soon and perhaps a radio talk. In two weeks, we will be breaking ground for a new Law Enforcement and Court House, located near the Justice Center. We have \$15-17 million dollar budgets and are researching requirements to attain operation and maintenance funding. After some city hurdles are overcome on 10 acres of land that we purchased in Bismarck, we will be developing a long term treatment facility, outreach clinic, and wellness center with some ancillary offices. We are looking at a two year timeline and seeking Federal grants and State collaboration. The State would like to see a regional facility, so there is the possibility of collaboration with the State. Chairman Fox discussed the third distribution and concerns with deductions and a little of the history of that initiative. Councilman L. Kenneth Hall stated that BIA 6 is slated to be completed and thanked the Tribal Business Council for supporting the project. He also informed the audience of the groundbreaking of a 36-unit apartment building in New Town, north of the Phase 1 Housing with 5 million in infrastructure. Councilman Hall also commended the Little Shell Celebration Committee and all the activities that took place. The Peoples Feed had 4-500 visitors and overall Little Shell went very well. Councilman Mervin Packineau stated that last week or so at the TERO Conference, Duane Young Bird was awarded Compliance Officer of the Year.

## III. SPECIAL GUESTS – ELDERS

## A. Coalition for Change - Joletta Bird Bear

Joletta Bird Bear, Delvin Driver Sr., and Hanks Bolman presented. Joletta Bird Bear read a prepared statement for "Citizens for Change" requesting a Federal investigation of former Chairman Tex G. Hall from the Denton Report of Aug. 2014. Jolette Bird Bear read a written statement that was submitted to the Secretary. The report was completed without subpoena powers, but even without is extremely incriminating. The Coalition for Change is requesting the Tribal Business Council go on record to support by formal action and resolution. The proposed resolution entitled "Official Governmental Action Request(s) to the U.S. Department of Justice; U.S. Federal Bureau of Investigation; U.S. D.O.I Bureau of Indian Affairs; and the U.S. Internal Revenue Service – Initiate a federal investigation of former Tribal Chairman Tex G Hall, pursuant to the findings of Denton LLP Report". Lead Attorney Caleb Dogeagle read an email correspondence forwarding the Denton Report to the Federal Bureau of Investigation. Former Three Affiliated



Tribes Chairman Tex G. Hall read a prepared statement of which (copy was presented to the Executive Secretary) advised the Tribal Business Council against the action as it has legal implications due to its slanderous nature. Chairman Mark N. Fox asked that the resolution presented by the Coalition for Change be edited to just address the formal presentation of the Denton Report to the Agencies listed. Various members of the audience spoke for the passage of the resolution.

*Motion:* Councilman Frank Grady moved to support the request of a Federal Investigation subject to rewording by the Legal Dept. and drafting a resolution.

#### VI. TREASURER'S REPORT - Councilman Mervin Packineau

#### A. Pat Packineau

Pat Packineau discussed a personal issue concerning his home access to rural water. Maynard Demaray stated that it was out for bids. A number of Councilmen specified similar holdups. Maynard Demaray discussed funding issues with budget cuts from D.O.R. Chairman Mark N. Fox asked what would it take to get it done. Councilman Mervin Packineau stated that a year ago we moved to get it done. Maynard Demaray stated that the bids are going out in two weeks.

Pat Packineau changed the conversation to the Casino and matters of the escrow account for the Event Center Renovation, which needs to be deposited from July onward. He is also requested that in the future that the Casino Financial Report be presented in Closed Session. Chairman Mark N. Fox recommend just giving percentages and Pat Packineau agreed. The Casino Report will be on the September 2<sup>nd</sup> Tribal Business Council Agenda.

#### B. Noreen Two Crow

Noreen Two Crow is seeking an Education grant to cover unmet need for her grand-son Dexter for the amount of \$2,500 and a \$2,250 Educational loan. Dexter is transferring from Dickenson to Wahpeton and pursuing welding.

#### C. Kenny Gillies

Kenny Gillies stated that due to \$7,800 in default student loans from the Bank of ND, he can't finish pharmacy school. He is seeking a grant to pay off and wants to come home and work. His goal is to become the Head Pharmacist at Elbowoods Health Center. Mr. Gillies was almost done with his degree when he was sent to Iraq.

The Chairman and Legal expressed concerns over the original water agreement with rural water and the need to reevaluate.

**Discussion:** Chairman Mark N. Fox has serious concerns on how this will decrease our leverage with the City of Parshall over the main water agreement and possible 1926B violations including



free water for the tribal members within the city. Councilman Mervin Packineau expressed his concerns on completing Segment projects such as Taco John's, the apartments, and housing areas. Patrick Dubois stated that the City is saying their sewer system can't handle the increase. Chairman Mark N. Fox gave a history of the anti-tribal attitude to be conducive to the Tribe's needs. Councilman Mervin Packineau stated that we can still go back to the main agreement and this is just for the new edition. John Fredericks stated that Fort Berthold Rural water pays the city for the water that the City uses. That's never made any sense to me. You're paying twice basically. Patrick Dubois stated that we are having the same problems with solid waste because we are not allowed to go in there.

## Gravel Pit Agreement (Eagle Rock Timber, Inc.)

\$1.50/ton in the agreement. Councilman L. Kenneth Hall asked John Fredericks if it would be a trespass issue. John Fredericks stated that it depends on whether that was a condition of the original agreement. We have been accruing royalty on what has been sold already at \$1.50/ton. Add fee for storage and compensation/royalty for gravel already mined gravel. We will return the issue to the Tribal Business Council with the numbers and agreement.

Legal will look into the contract rights and if they would transfer and or be null and void. We don't want any of the children coming back and resuming the claim on the lease. *Item deferred to the September 2<sup>nd</sup> Tribal Business Council meeting.* 

#### U. Michael Yellow Bird

Michael Yellow Bird, Tara Beckenstal, and Michael Morris presented a report of research and an intervention funded by a small grant. What we hope to do is bring together an expertise on the Human-animal bond and different aspects of human-animal interaction. Dr. Yellow Bird approached us with the problem of the free roaming dog issue. We talked with residents on how



they view dogs, and will try helping address the issue through human intervention, policies and traditional knowledge. The group is seeking assistance in the amount of \$2,921 for hotel rooms. The item will be presented back to the Tribal Business Council after June 2016.
