The tribe is very concerned about a letter about royalties in the riverbed and second letter concerning non-payment of taxes. We will continue to address this issue and hope to iron out our differences soon. The State will be here tomorrow for the opening main street of New Town. Another issue is curtailing flaring and adoption of rules and regulation. A number of meetings were attended that addressed the issue at NCAI and Federal Partner Meetings. We stated our position at NCAI concerning duel taxation as an impediment. Upcoming meeting at NIGA in November to discuss formal position that Executive members should be elected, investors meetings, and MRR developments during INFR. Meeting for MRR and the refinery. Impacted parties meeting concerning water related issues. Next Tribal Business Council will be on November 12<sup>th</sup>. Congratulated the New Town Cross-Country Team on its state championship and its nearly perfect score. Also great performances from all of our runners from each Segment. Stated that a special recognition with take place on Nov. 12<sup>th</sup> with a reception to follow. Discussed the Chairman's Bowl and the success of the event. Stated that these are good examples of the effects of the tribe putting money into these programs and receiving positive results.

## V. VICE CHAIRMAN'S REPORT - Councilman Randy Phelan

### A. Native American Rights Fund (NARF)

Matthew Campbell, NARF Staff Attorney (on Phone) joined the meeting. Councilman Randy Phelan informed the Council that John Echohawk and Mat Campbell were in supported of the Tribe on the issue of duel taxation and the Cotton Petroleum Case. We also attended a Federal Partners meeting and discussed and clarified for them many important issues. Councilman Randy Phelan informed the audience of the upcoming Halloween activities in Mandaree. Caleb Dogeagle & Prairie Rose Seminole discussed concerns with the Voter ID law changes and how it impeded native vote in 2014. Prairie Rose Seminole stated that in 2012 poll watchers observed 4 people turned away, and 2 told they were at the wrong location in New Town. No poll watchers were available in the other communities on the reservation. Councilman Mervin Packineau stated that this really needs to be looked at, and we all should be able to vote wherever. We need to have a conversation with the Counties as to where we want our poll locations. Matt Campbell stated that NARF is looking to repeal the new voter ID law. A Lawsuit is being filed in the ND District Court with several constitutional claims. Caleb Dogeagle stated that NARF is covering the costs and asked if TAT would want to be named in the suite also. Chairman Mark N. Fox stated that our inclination is to support, but our role will have to be discussed and determined by the Tribal Business Council. We may also provide a general contribution for NARF to further pursue these type of endeavors. Councilman Randy Phelan thanked John & Mat for looking out for our Indian people. Tribal Leaders Tax Alliance, Austin Green, Warm Springs, Aaron Menendez of NCAI held a Meeting. Chairman Mark N. Fox could put in tandem with our Energy Group, NAC.
