
1) Homeless Shelter Update - Ruth Meyers

Jackie Hall presented an update for Ruth Meyers. 65% clients transfer to housing. 4 tribal members were of the 65%. Working with Indian Affairs to apply for housing off the reservation in lieu of Low Rent Housing. Homeless Apartment services to provide full time nutrition, daycare, 24-hour security, work force development, on site social services. Success rate for tribal members is much greater now. Kathy Eagle is researching some possible options through the Elbowoods clinics programs. About 150 car seats a year to tribal members.

F. EMHC CEO Report, Provider Contract, Medicus Contract for Provider Recruitment, Sitnasuak Health Solutions – Kathryn R. Eagle

Summited monthly report. Having issue with clinics to officially budgeted. Third party billing deposit with proposed \$1.1 million. Below from last year but with consultant and change to RPMS is reflected on this. Still concerned on not having a governing body but accreditation org is fine with this at this point because we did have a Board meeting. Working on DUNNS numbers issues with grants. Needs support to move forward with the James filing proposal. Sitnasuak Health Solutions & James Filing submitted a Tier 1 & 2 RPMS proposal. Will be able to provide reports on suicide to meet the GPIA standard from the system and see revenue generation and patient complaints go down. Working on bring more staff on through Barton & Associates & the Echo Group Contract for supplemental staff and physicians. Fees range from \$14,000-16,000/hire. Councilman L. Kenneth Hall informed the audience that Dr. Mayer was also responsible for recruitment previously and could be a duplication of services. We could use 2 more providers to prove full service for patients/day. The field clinics are being covered but there is room for improvement. Discussion on 638 contract review and audits to attain mature status. The original contract was at hospital level service and this is being changed to a lower level to allow us to better meet the auditing requirements. Al Nygard recommends Medicas on a temporary basis for recruitment. Experience Health ND case management program such as pulmonary, asthma, business associate agreement to share patients to assist with preventative health care. Also request from the CDC and Great Plains Epicenter for prenatal mom and drug use for support letter from the tribe.



Motion: Councilman L. Kenneth Hall moved to forward Sitnasuak Health Solutions to the February 11th, 2016 Tribal Business Council with a recommendation for approval. Councilman Cory Spotted Bear seconded the motion. Vote: 3-0-0-0. Motion carried.

Discussion: benefits will be training for staff. Madonna Azure stated that Government Performance Improvement Act (GPIA) and RPMS will be great for gathering data and grants. Discussed buy back shares that are not fulfilling our need and recommend we hold those back.

Motion: Councilman Cory Spotted Bear moved to forward MEDICUS for a three month trial with negotiation cost to the February 11th, 2016 Tribal Business Council and plan for an in-house recruiter. Councilman L. Kenneth Hall seconded the motion. Vote: 3-0-0. Motion carried.

Madonna Azure & Kathy Eagle will meet to re-establish a formal managed care system. Discussion of developing a compliance plan as was done before. CMS report from Cindy Smith will be out the end of the month and recommends the state remove the IAM information box on their forms for Medicaid. Madonna Azure provided an update for Elder Care services.
