# III. PROGRAM REPORTS:

## a) Tourism – Darian Morsette, Director

Provided information on the Round Dance on Feb. 19<sup>th</sup>, 2016. Earth lodge project budget question if the \$100,000 was to go to Special Projects or Tourism. Tourism still needs an operating budget. He has a draft budget of \$500,000.

*Motion:* Councilman Fred Fox moved to support a Tourism budget of \$115,000 Operational Budget and \$110,000 for the completion of the earth lodge project. Councilman Cory Spotted Bear seconded the motion. Vote: 3-0-0. Motion carried.

**b) TERO** – *Charles Foote* 

Shawn Red Fox presented the TERO report. The Committee asked that TERO regularly attend this committee to give updates. Discussed issue of Tier 1 companies not paying their TERO fees. Councilman Fred Fox believes there are issues with both Tier 1 & the sub-contractors. We need to forward with the TERO Management in attendance.



*Motion:* Councilman Fred Fox moved to approve interim suspension of all Teir-1 companies & Sub-Contractors that have not paid TERO Fees and forward to the Feb. 11<sup>th</sup> 2016 Tribal Business Council. Councilman Cory Spotted Bear seconded the motion. Vote: 3-0-0. Motion carried.

- c) Planning and Grants Sheila Many Ribs Item deferred.
- d) Housing Lawrence Baker

Presented a resolution entitled "Authorization for Housing Services Program to Negotiate Contracts Less Than \$15,000 Without Formal Bid Process". Working with HOB at this time for furnace work as a sole source. Also the 3 trailers approved for Tara Yellow Bird, Crystal Hallam, and Anita Deane trailer purchases.

*Motion:* Councilman Fred Fox moved to forward to the Feb. 11<sup>th</sup>, 2016 Tribal Business Council. Councilman Cory Spotted Bear seconded the motion. Vote: 3-0-0. Motion carried.

*Motion:* Councilman Fred Fox moved to forward approval of \$100,000/trailer for a loan for each buyer to purchase the trailers and to forward to the Feb. 11<sup>th</sup>, Tribal Business Council meeting. Councilman Cory Spotted Bear seconded the motion. Vote: 3-0-0. Motion carried.

e) Business Loans - Toni Starr

Presented a list of Business Loan applicants and ledger of current loans. Independence program collections are at \$117,000. Councilman Fred Fox stated that loans with no payment total is over a million and a half. Can we publish the names? Caleb Dogeagle discussed collection processes.

*Motion:* Councilman Fred Fox moved to forward garnishment of wages of tribal employees to recover similar to the state to forward to the Feb. 11<sup>th</sup>, 2016 Tribal Business Council meeting. Councilman L. Kenneth Hall seconded the motion. Vote: 3-0-0. Motion carried.

*Motion:* Councilman Cory Spotted Bear moved to blacklist anyone trying to do business with the tribe if they have delinquent TAT loans and forward to the Feb. 11<sup>th</sup>, 2016 Tribal Business Council. Councilman Fred Fox seconded the motion. Vote: 3-0-0. Motion carried.

a) Flower Shop & Hair Salon - *Shylah Demaray & Valorie Demaray* Seeking 2 buildings for the above businesses.

*Motion:* Councilman Fred Fox moved for the businesses by approved for the TERO buildings on New Town Main St. And to be forwarded to the Feb. 11<sup>th</sup>, 2016 Tribal Business Council meeting and subject to building assessment. Councilman Cory Spotted Bear seconded the motion. Vote: 3-0-0. Motion carried.

b) Financial request Fitness Event - Whirlwind Bull

*Motion:* Councilman Cory Spotted Bear moved to forward approval of 75% of the total for \$11,250 to the Feb. 11<sup>th</sup>, 2016 Tribal Business Council. Councilman Fred Fox seconded the motion. Vote: 3-0-0. Motion carried.

c) Safe Haven in Mandaree - Catherine Young Bear

Draft Policies & Procedures, strategic plan, and budget presented to the committee. Will be seeking 14 staff, dealing with all types of issues, will need staff training. Staff may need to be med certified and CNA Certified by the State. \$690,152.16 budget request. Committee recommended starting a basic operation with 1 or 2 staff due to budget restraints.

*Motion:* Councilman Fred Fox moved to forward to the Feb. 11<sup>th</sup>, 2016 Tribal Business Council. Councilman Cory Spotted Bear seconded the motion. Vote: 3-0-0. Motion carried.
