C. Western Energy Alliance Discussion

Chairman Mark N. Fox spoke to the audience concerning impending taxation concerns for the MHA Nation and operators. Attorney John Fredericks discussed the recent hearing and injunction. Doubts if WEA will get its injunction. Kayla Danks discussed various issues from the BIA's point of view. Steve Simpson discussed as solicitor for Right of Way answered questions via phone from the audience. Such as service line as a temporary above ground water line. Also temporary water lines on full ROW.

FTR: Councilman Mervin Packineau joined the meeting at 2:38

Oral argument on Monday morning with no opinion from the judge. Has asked the Assistant Secretary of Interior who is not willing to extend the start date on April 31st. Also discussed waiver of evaluation. Tribal interest permission is sought with any percentage of interest. The rule applies to all aspects of ROW, not retroactive, and also applies to mortgages. Abandonment defined as grants sites they are giving it up by notifying the BIA or action like ripping up pipes. Non-use is defined abandonment for about 2 years [169.408] various scenarios (examples; 3 pipelines approved and 2 completed, third on not completed is an instance of abandonment). To keep the land owner and the BIA informed as a rule. Important to provide a construction schedule as part of the ROW application. Template Form for consents and handbook. (On the phone), they can investigate. The Chairman's statements give us resources to look into. Chairman Mark N. Fox requested an overall report and asked that a process be put into play. The existing rights are not affected. If there is not a? on the line, it is trespassing. Chairman Mark N. Fox recommends putting together a form that shows compliance. May 4th is the deadline for drilling. Councilman Randy Phelan asked for drat letters of support to present for their next trip to DC.
