Read into the record some comments from a local survey conducted related to oil & gas industry pipelines crossing the lake or river. Also submitted a Change.org petition opposing the pipelines and presented a Duke University Study concerning the brine spill near Mandaree. Chairman Mark N. Fox asked the group for help opposing the 3 proposed pipelines north of the reservation. Chairman Mark N. Fox thanked the group for their advocacy and asked the



group to join with the Tribe against the States' assertion of authority over the riverbed and the new pipelines upriver and off the reservation. The Chairman asked the group to participate in a working session to discuss the issues. Discussion of the differences between pipeline trenching vs. boring.
