## III. <u>NEW BUSINESS:</u>

#### A. Public Safety

## 1. Drug Enforcement

Information provided concerning which officers needed adjudication and a time table to completion; Dawn White (renew or refresh), Chief Gerald White Jr., and Jeff White were just notified that they would need adjudication at the Tribal level. Caleb Dogeagle expressed the importance



of having this completed as soon as possible. Sarah Dogeagle stated that the process takes 30-90 days. Councilman Fred Fox & Councilman Randy Phelan had serious concerns over cases presented by officers and investigators without adjudication. Two investigators will be receiving ATF adjudication but Al Nygard and Barlow Wells confirmed that they all would need Tribal adjudication.

*Motion:* Councilman Randy Phelan moved to appoint Special Agent Chad Coulter as Chief of Drug Enforcement on an interim basis until Chief Gerald White Jr. is adjudicated. Gerald White will be limited to administrative duties. Councilman Frank Grady seconded the motion. Vote: 3-0-0. Motion carried.

*Discussion:* All those requiring adjudication shall be expedited.

#### 2. Drug Enforcement Incident

Discussion of department restructure, familiar connections, Public Safety staff member Brittney White injury while on duty and clearance through remediation. Al Nygard, CEO recommends finding a Public Safety Director to alleviate some of the command and control structure. Discussion of proposed Public Safety organizational structure and adjudication. The need for Segment security needing the protection of adjudication. Discussion of each in the office individually handling their own time with memorandum to each staff member in the office.

# **1.** New Town School Gun Incident – Grace Her Many Horses and Chief Nelson Heart

Incident occurred today with New Town Police Chief bringing in TAT Law Enforcement. Discussion of the use of security guards at the schools and metal detectors. After a search of the school ammunition and knives was found. Councilman Randy Phelan discussed purchasing the schools metal detectors. Councilman Frank Grady expressed the need for the Tribal Building to also have the metal detectors. Also discussed was employee Mavis Ball transfer and salary discrepancy and general wage scale iniquities between departments. She also expressed the desire not to be mis-treated at Drug Enforcement.

#### 2. Other

Discussion of patrol bikes at each segment. Presented the need to change the office arrangement in the new court house to move SORNA away from Law Enforcement and need for a construction change order.

*Motion:* Councilman Randy Phelan moved to forward Change Order to the October 19<sup>th</sup>, 2016 Tribal Business Council meeting. Councilman Frank Grady seconded the motion. Vote: 3-0-0. Motion carried.



*Motion:* Councilman Randy Phelan moved to forward the purchase of Metal Detectors for each reservation school from 380 to the October 19<sup>th</sup>, 2016 Tribal Business Council meeting. Councilman Frank Grady seconded the motion. Vote: 3-0-0. Motion carried.

Discussion: SRO to be sought by Law Enforcement.

#### C. Richard White Tail

Presented incident with Game Warden & Animal Control entering yard taking pit bulls. Trying to do complaint on them the Game Warden. Complaint filed against him by the court. Caleb Dogeagle will research registering or permits for prohibited dogs and return to the Judicial Committee meeting on the 18<sup>th</sup>.

Rezco not paying Mr. Baker's company for trucking work done (for water) during divorce proceedings of Rezco owners (Coby Little Soldier?/White Bear). Discussion of history of TERO restrictions. Suggestion of a lean type mechanism paid to TERO for type of situations.
