Discussion: Lawrence Baker explained that none of the 210 Homes (Not switched over to Home Mortgage) have not been paid for. Lawrence Baker will present a report to the Economic Committee. Councilwoman Monica Mayer asked that an audit be performed of the 210 homes. Councilwoman Monica Mayer commented on the number of homes in North Segment that need to be audited. Councilman Randy Phelan explained the reason why West Segment developed their own Housing Program due to the poor services that HUD provided. Councilman Randy Phelan noted that Fort Berthold Housing gets 1 million a year that is only used for staff. Discussion of HUD homes that are boarded up and should be condemned but HUD won't take them off their inventory. Councilman Fred Fox stated that it is a huge problem reservation wide. Councilwoman Monica Mayer noted the meth issues & remediation. Councilwoman Monica Mayer asked the CEO for a list of tribal business and

Cassie Mahto is seeking resolution to a probate issue of tribal property and a tribal house. Brother Louis was trying to sell the tribal fee property. The value of the home is \$65,000. He has issues with the land lease going to the sister. Cassie would like to live in the home and lease the land. Lawrence Baker stated that it was an elder home that went to Felix and then to his wife after his passing. Originally was supposed to be \$150/month but never was set up according to minutes from 2001. Cassie has signed the papers to purchase, but the land was leased to the sister. Councilman Randy Phelan believes that legally the sister's home site resolution would need to rescinded (15-216-LKH) and that it should become a home site and be just a lease. Lawrence Baker requested that the home and lease go to Cassie Mahto with a resolution.
