C. TAT Tribal Court – Wynona Traversie, Court Administrator

Presented report presented. The Chief Judge position is currently being advertised along with a Prosecutor and a Defendant Prosecutor. Councilwoman Monica Mayer asked if 180 days past due, is there a time frame to have this done? No statute of limitations. Kermit Heart discussed updating the warrant lists going back 5 years. Some of the people on the list are deceased. Time frame of maybe 2-3 month to work on it. Councilwoman Monica Mayer said we could send over some workers to get it done faster. Lisa Redford is being



considered to help with the warrant list back log due to past experience. Councilman Fred Fox recommended bringing in a consultant to help with this. It was noted that there a lot of civil cases with from TERO too. Judge Mary Seaworth stated that they have gone from a 500 case back log to 30 cases. We are setting up a docket system to keep up with these civil cases. Councilman Fred Fox, another question is the Speedy Trial rule, with some cases in limbo.
