**B.** Fort Berthold Power - Theodora Bird Bear, Joletta Bird Bear, Thomos Abe, & Lisa Deville. Power (Protectors of Water Earth Rights), a local citizens group brought forth concerns before the Council about flaring regulations and testimony the group has provided. Provided information on BLM regulation entitled "Waste Prevention Production Subject to Royalties And Resource Conservation" also know as the "No Waste Rule" and proposed changes and repeal that started in 2014 concerning flaring and gas capture to market and pay allottees. Discussed the health impacts and ensuing legislation to combat the effort to repeal the current BLM protections. The group will be attending Sen. Hiedtcamps' forum tomorrow to support and ask for her support for the current regulations. Tom Abe expressed his global warming concerns. Lisa Deveille proved information concerning methane release from flares, climate & health effects. Theodora Bird Bear discussed responsible development concerns and set-back rules. Chairman Mark N. Fox provided his perspective of flaring regulations in current polical climate. Councilman Fred Fox noted that 13% of all natural gas is being flared with 75% more development, Oil & Gas Ordinance, longer TAT Set-back, lack of BLM Engineers for well inspection. Chairman Mark N. Kelly Hosie presented a request for her brother in the amount of \$24,666.22 in financial assistance to pay for hospital bills not covered by his Boon Insurance. Boon Insurance only covered \$2000 in 2016. He has submitted a letter from Boon Insurance verifying that his coverage had reached the maximum amount. Mr. Vocu had a total of \$29,000 in medical bills and still owes \$24,666.22 for the critical care services between a hospital, 2 clinics and the ambulance services. He was off the reservation and was found unconscious so didn't go thru I.H.S. Councilwoman Monica Mayer noted that he had 72 hours by policy to submit this to I.H.S. Councilwoman Frank Grady recommended assistance in the amount of \$25,000. Councilwoman Monica Mayer recommended Life and Limb for the maximum amount of \$25,000. Boon Insurance noted that the claim can be back dated and revisited since the Tribe owns the plan.
