A, Request for Vernon White Body – Starla Deane, Supervised IIM Specialist October 2016 received a request to concerning Vernon White Body who reside in the Lakeside Assisted Living Center. She sold her dad's house in Texas for \$21,000. A bill at Lakeside Bank was \$44,224. She couldn't get him on Medicaid due to the house sale. The bill is now at \$48,548. He generates less than \$900 each month from his trust account. Starla Deane is requesting money from the tribe. We have \$5,000 that can assist, its Adult Institutional Care Services. Councilman Frank Grady said we have had some of these requests before. 75% not to exceed \$25,000.

Motion: Councilman Frank Grady moved to forward a request for \$25,000 according to the policy to the May 10-11 Tribal Business Council. Councilman Cory Spotted Bear seconded the motion.

Amend Motion: Councilman Frank Grady moved to forward \$25,000 according to policy, and approve to apply the Adult Institutional Care Services in the amount of \$5,000 to the bills and forward to the May 10-11 Tribal Business Council. Councilman Cory Spotted Bear seconded the motion. Vote: 3-0-0-0. Motion carried.

Discussion: Councilwoman Monica Mayer states now that we are helping him with the bill to bring it down to \$18,000. A 960 form should have been done thru Social Services. Now you will have to decide if you will be pressing for Elder's Abuse.
