D. Marvin Driver Range Unit Request – Marvin Driver & Valorie Hosie

Mr. Driver presented additional information that was not considered in his application for Range Unit 8. He is requesting the approval be reconsidered as requested by NRC with a letter from Jessie Baker relinquishing one of his allocations. Jessie Baker has since changed his mind about giving up one of his three allocations. Chairman Mark N. Fox noted that incomplete information provided at the time the allocations where approved from the BIA has caused complications in the overall process. Marvin Driver's home is only two miles from the allocation he is seeking. Councilman Mervin Packineau noted the bigest factor is who had it before. Valorie Hosie noted that Tom Wells, BIA scored Marvin Driver higher. Councilman Randy Phelan stated the the BIA forgot Range Unit 210 that is not on the list. Valorie Hosie noted that Karen Hartman disolved that unit and others that have gotten too small. Councilman Mervin Packineau asked for scoring sheets be presented during the time of approval. Jessie Baker is willing to follow the process. Chairman Mark N. Fox asked the the BIA reasses in conjunction with the BIA rating according to the criteria. Valorie Hosie noted that the range study is sub-standard and experianced problems getting the range unit resolution drafted due to the BIA's numorous changes. Mr. Driver was also told that he didn't need to be at the meeting for approval. Councilman Randy Phelan recommended letting the appeal process take over or Mr. Baker & Mr. Driver can agree to share the range unit 55. Jessie Baker paid for the unit the past two years. Jessie Baker is willing to run in common. Marvin Driver is willing as long as it grows as his heard grows. Valorie Hosie noted that the range units have not been signed at the B.I.A. and some range units were not all prensented by the B.I.A.
