### **B.** Leo Cummings

Presented issues with his grazing permit and being able to use it. Asking for clarification on it's use. A well pad has been built and gound has been cleared on the south end for housing. Lost two springs and use of the land and spring water & dam. BIA has not adjusted for the development. Total unit is 245 acres. Some fences have been taken down and he can't run his horses into the unit. AsSeeking the Council's recommendation for solution. Chairman Mark N. Fox's main concern is why the BIA hasn't adjusted what Mr. Cummings is paying. Councilman Frank Grady noted that he has been restricted by budget to put in fence work on the housing development, but will try to get it done in about a week. About 50 acres lost.

**C. Parshall School District**- *Beth Swartz, Billy Moran, & Trevor Huffaker* Informed the Council about issues with the Elementry and High School facilities. It would cost \$7-10 million to bring the facilities up to code. The High School is in worst shape of the two.





An Education Adequacy Study has been completed. Presented various Project funding options with coresponding costs. [See handout]. Discussed the improved services and benefits. \$9 million is the maximun that be presented to the school board. Councilman Mervin Packineau noted that native student count is at 70%. Chairman Mark N. Fox asked about further hybrid plans. The Archetect noted that further meetings are occuring to develop additional scenereos. Chairman Mark N. Fox discussed the possibility of not including a new gymassium. Discussion of State tax levi and 2% loan value. Councilman Randy Phelan recomends option 1# funding for a loan and agreeable to giving the old K-6 elementry to the tribe and noted Mandaree still needs a new Elementry. Ms. Swartz hopes to finish the project by 18 months and done by the Fall 2018.

Kayla Danks, BIA noted his account was currewntly restricted and the regional office appealed by the Interior Board. Not appealed at the regional office. Interested parties can file an appeal. Attourny Bruce Wingstrum, Detroit Lakes, MN. filed in tribal court and succeded in removing guardianship from Mr. Many Ribs's sister Karen Sky that eventually went to the attourny. Chairman Mark N. Fox noted the questionable grounds and the concern of why the Power of Attourney was removed and not given to another family member allowing Mr. Wingstrum to step in and take the Power of Attourney. Councilwoman Monica Mayer recomends that a 960 be filed against attourny Wingstrum. Discussion of restricting Mr. Many Ribs's I.A.M account. Starla Deane noted this has been already done and Mr. Wingstrum appealed the restriction and it was reversed by the regional office.
